The Grants Committee meets quarterly on the last Wednesday of March, June, September and December. A report is expected at project completion; for multiple year projects, a progress report will be expected annually. This project is focused on bringing people with disabilities to our community. It will focus on our local establishments, restaurants, motel/hotels and tourist attractions. The project will focus on supplying a video of local establishments showing their accessibility to people with disabilities. It provides visual content of the establishment including doorways, restrooms, hallways, walkways, entrances, etc. These videos will be available on the Chambers website and Travel Oregon, so people with disabilities looking for a place to visit will be able to see how accessible our community is. They can pick and choose what will fit with their disability and know where they can go while they are in town.

As a person with a disability I can tell you by experience that when I find a town, motel, restaurants or entertainment that fits my disability, I return often. I bring family and friends to join me. This will increase visitors to our community who may not otherwise visit us not knowing where they can go while they are here. Now they have a visual of where they can go.

We will track the businesses by spreadsheet that have been completed and verify they are on the websites as stated. With the funding requested, we should be able to get approximately 13 – 14 businesses completed within the next few months. This is just a start. There are well over 100 businesses that would benefit from this promotion in our local community.
