**Background:** On April 20 to April 24, 2026, in recognition of National Child Abuse Prevention Month, the Umatilla County District Attorney's Office, in partnership with the Guardian Care Center (GCC), is hosting the fourth annual Eastern Oregon Child Abuse Conference (EOCAC) (previously titled the George Murdock Eastern Oregon Regional Child Abuse Conference) to be held at the Wildhorse Resort in Pendleton, Oregon.

Originally, the conference was a three-day event, but it has now expanded to a week-long training. It was tailored for law enforcement and prosecution, but this year will include a track for advocates, social workers, educators, and forensic interviewers. It begins with the Internet Crimes Against Children and Prosecutor Bootcamp on Monday and concludes on Friday. The GCC Charity Golf Tournament typically follows, if scheduling permits.
