

Dear Voters,

This Voters' Pamphlet is provided for assistance in casting your vote-by-mail ballot. Local candidates and committees have paid to have their material printed here. Candidate statements are printed as submitted and not all candidates submit material. All federal and state candidates will appear in the states' section. Not all races will be on each ballot type.

Your ballot packet will arrive by mail approximately 3 weeks prior to election day. Enclosed you will receive your ballot, a secrecy sleeve and return envelope. To vote, completely fill in the oval to the left of the response of your choice. When you have completed voting be sure to <u>sign the voter's oath on</u> <u>your return envelope.</u> Your ballot cannot be counted without your signature.

If you lose or spoil your ballot you may request a replacement ballot by calling our office at the number listed below. One will be mailed to you provided the request is made with sufficient time for mailing. Otherwise, you may pick up a replacement ballot in person at the county elections office. Office hours are from 8:00 a.m. until 5:00 p.m. Monday through Friday, and from 7:00 a.m. until 8:00 p.m. on election day. If you have moved or changed your mailing address you may update by going to www.oregonvotes.gov. All <u>new</u> registrations must be received or postmarked by October 18<sup>th</sup>.

Election day is November 8, 2022. Ballots must be received by 8:00 p.m. on election day in a designated drop box or postmarked by the USPS on that day. Ballot drop sites will be available from September 23, 2022 through election day. Ballot deposit locations and hours available for use are printed in this section.

In 2021, the Oregon Legislature passed the Voter Language Access Bill (HB 3021) requiring the Secretary of State to translate portions of state and county voters' pamphlets into Oregon's most spoken languages. The law seeks to remove barriers to voting for those who are not fully proficient in English. The bill's requirements are being implemented for the first time this election.

To help in this effort, the Translation Advisory Council was created. The Council is made up of volunteer community members who represent the ethnic, linguistic, and cultural diversity of Oregon voters. Council members make sure translations are accurate and retain the original tone and meaning in a culturally appropriate manner.

PROHIBITS PSILOCYBIN-RELATED BUSINESSES WITHIN THE CITY OF UMATILLA.

**QUESTION:** Shall the City of Umatilla prohibit psilocybinrelated businesses within the city?

**SUMMARY:** State law permits persons licensed, controlled, and regulated by the State to legally manufacture psilocybin products and provide psilocybin services to persons 21 years of age and older. Psilocybin is a hallucinogenic chemical that is obtained from certain types of fresh and dried mushrooms. State law authorizes the governing bodies of cities and counties to adopt ordinances to be referred to voters that prohibit the establishment of psilocybin product manufacturers and psilocybin service center operators within the area subject to the city or county's jurisdiction. The City of Umatilla is referring of psilocybin product manufacturers and psilocybin product manufacturers and psilocybin service center operators within the establishment of psilocybin the city of Umatilla.

#### **Explanatory Statement**

In November 2020, Oregon voters approved Ballot Measure 109, known as the Oregon Psilocybin Service Act (codified as ORS 475A). Psilocybin is a hallucinogenic chemical that is obtained from certain types of fresh and dried mushrooms.

**QUESTION:** Shall the City of Hermiston prohibit psilocybinrelated businesses within the city?

**SUMMARY:** State law permits persons licensed, controlled and regulated by the State to legally manufacture psilocybin products and provide psilocybin services to persons 21 years of age and older. Psilocybin is a hallucinogenic chemical that is obtained from certain types of fresh and dried mushrooms. State law authorizes the governing bodies of cities and counties to adopt ordinances to be referred to the voters that prohibit the establishment of psilocybin product manufacturers and psilocybin service center operators within the area subject to the city or counties jurisdiction. The City of Hermiston is referring to the voters an ordinance prohibiting psilocybin product manufacturers and psilocybin service center operators within the City.

Approval of this measure would prohibit the establishment of psilocybin product manufacturers and psilocybin service center operators within the area subject to the jurisdiction of the city.

#### **Explanatory Statement**

TO PROHIBIT PSILOCYBIN-RELATED BUSINESSES WITHIN THE CITY OF ECHO.

**QUESTION:** Shall the City of Echo prohibit (Ban) psilocybinrelated businesses within the City limits?

**SUMMARY:** State Law allows operation to manufacturer, distribution and possession of psilocybin and psilocin.

State Law provides that the Echo City Council may adopt an ordinance to be referred to the voters to prohibit (Ban) the establishment of any of those registered or licensed activities. Approval of this measure would prohibit (Ban) the establishment of psilocybin product manufacturers and or psilocybin service center operators within the jurisdiction of the City of Echo.

#### **Explanatory Statement**

Approval of this measure would prohibit (Ban) the establishment and operation of psilocybin-related businesses within the City of Echo.

The Echo City Council has adopted an ordinance prohibiting (banning) the establishment of psilocybin-related businesses within the City of Echo. As a result of this action, they must refer this measure to the voters.

If the measure is approved, the City of Echo would prohibit (ban) psilocybin-related businesses within its jurisdiction.

PROHIBITS PSILOCYBIN-RELATED BUSINESSES WITHIN THE CITY OF PILOT ROCK.

**QUESTION:** Shall the City of Pilot Rock prohibit psilocybinrelated businesses within the City?

**SUMMARY:** State law permits persons licensed, controlled and regulated by the State to legally manufacture psilocybin products and provide psilocybin services to persons 21 years of age and older. Psilocybin is a hallucinogenic chemical that is obtained from certain types of fresh and dried mushrooms. State law authorizes the governing bodies of cities and counties to adopt ordinances to be referred to the voters that prohibit the establishment of psilocybin product manufacturers and psilocybin service center operators within the area subject to the city or counties jurisdiction. The City of Pilot Rock is referring to the voters an ordinance prohibiting psilocybin product manufacturer and psilocybin service center operators within City limits.

#### **Explanatory Statement**

In November 2020, Oregon voters approved Ballot Measure 109, known as the Oregon Psilocybin Service Act (codified at ORS 475A), which allows for the manufacture, delivery and administration of psilocybin at licensed facilities. The vote in Umatilla County on Ballot Measure 109 was 11,330 (36%) in favor and 20,126 (64%) in opposition. ORS 475A.235 provides that the Oregon Health Authority will regulate the manufacturing, transportation, delivery, sale and purchase of psilocybin products and the provision of psilocybin services in the state. The Oregon Health Authority has initiated a rulemaking process to implement the state's psllocybln regulatory program and intends to begin accepting applications for psilocybin-related licenses on January 2, 2023. As of this date, the Oregon Health Authority has not completed the rulemaking process for implementing the state's psilocybin regulatory program, and the City of Pilot Rock is uncertain how the manufacture, delivery and administration of psilocybin at licensed psilocybin facilities will operate with the city. ORS 475A.718 provides that a city council may adopt an ordinance to be referred to the electors of the city prohibiting the establishment of state licensed psilocybin product manufacturers and/or psilocybin service centers in the area subject to the jurisdiction of the city. The City Council seeks to refer to the voters of the City of Pilot Rock the question of whether to establish a ban on state-licensed psilocybin product manufacturers and psilocybin service centers within the city's jurisdictional boundaries.

**QUESTION:** Shall the City of Milton-Freewater prohibit psilocybin-related businesses within the City?

**SUMMARY:** State law permits persons licensed, controlled and regulated by the State to legally manufacture psilocybin products and provide psilocybin services to persons 21 years of age and older. Psilocybin is a hallucinogenic chemical that is obtained from certain types of fresh and dried mushrooms. State law authorizes the governing bodies of cities to adopt ordinances to be referred to the voters that prohibit the establishment of psilocybin product manufactures and psilocybin service center operators within the area subject to the city's jurisdiction. PROHIBITS PSILOCYBIN-RELATED BUSINESSES WITHIN THE CITY OF ATHENA.

**QUESTION:** Shall the City of Athena prohibit psilocybin service centers and the manufacture of psilocybin products within Athena's jurisdictional boundaries?

**SUMMARY:** State law allows operation, manufacturing, distribution and possession of psilocybin and psilocin. State law provides that a City Council may adopt an Ordinance to be referred to the voters to prohibit the establishment of any of those registered or licensed activities.

Approval of this measure would prohibit the establishment of psilocybin service centers and manufacture of psilocybin products within Athena's jurisdictional boundaries.

#### **Explanatory Statement**

Approval of this measure would prohibit psilocybin service centers and the manufacture of psilocybin products within the City of Athena. Psilocybin is a drug derived from certain mushrooms. Oregon voters legalized psilocybin through Ballot Measure 109 (2020) which directs the Oregon Health Authority (OHA) to develop a psilocybin licensing and regulatory program for the State by January 2, 2023.

Ballot Measure 109 (2020) allows a local government to adopt an Ordinance to be referred to the voters that prohibits the establishment of certain licensed psilocybin-related businesses. The City Council of the City of Athena has adopted Ordinance #2022-07 declaring a ban on psilocybin service centers and the manufacture of psilocybin products within the jurisdictional boundaries of the city and referred the Ordinance to the voters. A "Yes" vote means psilocybin-related businesses are prohibited within Athena. A "No" vote means that psilocybin-related businesses would not be prohibited within Athena.

#### BONDS TO PROVIDE INTERMEDIATE SCHOOL BUILDING AND CTE SPACES

**QUESTION:** Shall the District issue up to \$45,200,000 in bonds to build school buildings and CTE spaces; receive \$4,000,000 matching grant? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.

**SUMMARY:** Umatilla School District proposes a bond measure not to exceed a principal amount of \$45.2 million and will receive state matching funds of \$4 million if bonds are approved.

If approved this measure would finance capital costs, including:

- Construction of new intermediate (grades 4-6) school building on South Hill to support increased students, including full-sized gym and increased playing field access.
- · Updates to CTE building for Clara Brownell MS.
- Construction of new CTE building at Umatilla HS, including future expansion space for classrooms and additional gym.
- Renovation of McNary Heights ES to become a K 3 school.
- Site improvements, demolition, furnishings, equipment, bond issuance costs.

Bonds may be issued in multiple series; each maturing within 31 years from issuance. The estimated initial, annual tax rate is \$1.19 per \$1,000 of assessed value with an estimated total annual tax rate of \$2.12/\$1,000 of assessed value for all District general obligation bonds. Actual levy rate may differ due to final interest rates and changes in assessed value.

#### **Explanatory Statement**

**Summary of the Situation:** In 2016, voters passed the issuance of a bond measure to renovate Clara Brownell Middle and update systems, replace roofing, and provide secure entry vestibules in each building. The estimated cost to voters was \$3.133/\$1,000 of assessed value. Due to the growth in the community since 2016, property tax payers are currently paying \$0.93/\$1,000 of assessed value for the approved 2016 bonds rather than the estimated \$3.133/\$1,000. Community growth allowed for the reduction in costs to individual property tax payers; it also has increased student enrollment.

The City of Umatilla estimates another 1,500 homes will be built in Umatilla over the next ten years, resulting in an estimated student increase of approximately 500 students. Current District school facilities lack the capacity to serve this growth.

What Would the Bonds Do? If passed by voters, the \$45.2 million of bonds and \$4 million matching grant already approved by the State would provide additional buildings and restructured learning spaces to support growth.

Proceeds from the proposed bond measure are expected to provide:

- A new 4-6 school building on South Hill including a fullsized gym and playing fields with room for expansion,
- Renovations to convert McNary Heights Elementary to a K-3 building,

- A new Career Technical Education building at Umatilla High School with room for expansion,
- Renovations to the current shop space at Umatilla High to convert it into elective and classroom spaces for Clara Brownell Middle School,
- Transition of Clara Brownell Middle School to a 7-8 building, and
- Site projects, demolition, furnishings, equipment and bond issuance costs.

How Was This Plan Developed? A facility review was conducted by an outside agency to assess facility needs, and a community group created a long-term facility plan for the District.

What Will the Bond Cost? The Umatilla School District projects are currently estimated to cost a total of \$49.2 million. The District has obtained Oregon School Facility Matching dollars in the amount of \$4 million to off-set the costs; however, the voters must pass the \$45.2 million bond to receive the \$4 million from the State. This bond measure is estimated to cost property tax payers in Umatilla School District an average of \$1.19/ \$1,000 of assessed value. This would change the assessed value of all District general obligation bonds to \$2.12/ \$1,000 of assessed value, which is \$1.01/\$1,000 of assessed value less than the estimated tax rate impact of the bonds passed in 2016. Actual levy rates may be different due to final interest rates and changes in assessed value.

How Will the Public Be Informed of Progress? Should the bond measure pass, the Umatilla School District would report progress on bond projects monthly to citizens as part of the regular school board meetings and would also provide periodic mailings with construction and renovation updates.

**SUMMARY:** State law allows operation manufacturer, distribution and possession of psilocybin and psilocin. State law provides that the Stanfield City Council may adopt an ordinance to be referred to the voters to prohibit the establishment of any of those registered or licensed activities.

Approval of this measure would prohibit the establishment of psilocybin product manufacturers and/or psilocybin service center operators within the area subject to the jurisdiction of the City of Stanfield.

#### **Explanatory Statement**

Approval of this measure would prohibit the establishment and operation of psilocybin-related businesses within the City of Stanfield.

A city council may adopt an ordinance prohibiting the establishment of psilocybin related businesses within the city, but the council must refer the ordinance to the voters at a statewide general election. The CITY OF STANFIELD city council has adopted an ordinance prohibiting the establishment of psilocybin-related businesses within the city and, as a result, has referred this measure to the voters.

If approved, this measure would prohibit psilocybin-related businesses within the City of Stanfield.

PROHIBITS PSILOCYBIN-RELATED BUSINESSES WITHIN THE CITY OF PENDLETON.

**QUESTION:** Shall the City of Pendleton prohibit psilocybinrelated businesses in the City of Pendleton?

**SUMMARY:** State law allows operation manufacturer, distribution, and possession of psilocybin and psilocin. State law provides that a City Council may adopt an ordinance to be referred to the voters to prohibit the establishment of any of those registered or licensed activities.

Approval of this measure would prohibit the establishment of psilocybin product manufacturers and/or psilocybin service center operators within the area subject to the jurisdiction of the City.

#### **Explanatory Statement**

Approval of this measure would prohibit the establishment and operation of psilocybin-related businesses within the City of Pendleton.

A City Council may adopt an ordinance prohibiting the establishment of psilocybin related businesses within the City, but the council must refer the ordinance to the voters at a statewide general election. The City Council of the City of Pendleton has adopted an ordinance prohibiting the establishment of psilocybin-related businesses within the City and, as a result, has referred this measure to the voters.

#### FIVE-YEAR LOCAL OPTION TAX FOR FIRE PROTECTION SERVICES

**QUESTION:** Shall the District impose \$0.9385 per \$1,000 of assessed value for contract fire protection services for five years beginning 2023-24?

**SUMMARY:** This measure would authorize the District to levy property tax at a rate of \$0.9385 per thousand dollars of assessed valuation each year commencing with the fiscal year beginning July 1, 2023 for five consecutive years. The proposed rate would raise approximately \$57,000 in tax revenues in each of the five years of the levy. The District would use the tax revenue from this measure to satisfy obligation to the City of Pendleton for contracted fire protection services within District boundaries. Without funding from this measure it is likely that the District will be unable to pay for contracted fire protection services, during the period of the proposed local option tax, from the City of Pendleton which would have a negative impact on residents of the District. Without contracted fire protection services there is the potential for increased homeowners insurance rates for residents of the District.

#### **Explanatory Statement**

This measure would authorize the District to levy property tax at a rate of \$0.9385 per thousand dollars of assessed valuation each year commencing with the fiscal year beginning July 1, 2023 for five consecutive years. The proposed rate would raise approximately \$57,000 in tax revenues in each of the five years of the levy. The District would use the tax revenue from this measure to satisfy obligation to the City of Pendleton for contracted fire protection services within District boundaries. Without funding from this measure it is likely that the District will be unable to pay for contracted fire protection services, during the period of the proposed local option tax, from the City of Pendleton which would have a negative impact on residents of the District. Without contracted fire protection services there is the potential for increased homeowners insurance rates for residents of the District.

BAN OF CERTAIN PSILOCYBIN BUSINESSES IN UNIN-CORPORATED UMATILLA COUNTY

**QUESTION:** Shall psilocybin manufacturers and service centers be banned from operating in unincorporated areas of Umatilla County?

**SUMMARY:** Psilocybin is a psychedelic drug found in certain mushrooms. Oregon state law allows for the licensed manufacturing and supervised use of psilocybin in licensed service centers. Oregon state law also provides that a county governing body may adopt an ordinance to be referred to the voters, to prohibit the establishment of these businesses within the areas subject to the jurisdiction of the county.

The Umatilla County Board of Commissioners has adopted an ordinance to refer to the voters that prohibits the establishment of psilocybin product manufacturers and service centers in the unincorporated areas of Umatilla County. Approval of this measure would prohibit the establishment of psilocybin manufacturers and service center operators within the unincorporated areas of Umatilla County.

A yes vote in favor of this measure will prohibit the certain psilocybin businesses and will not allow the licensed manufacturing and licensed service centers to operate in the unincorporated areas of Umatilla County.

A no vote against this measure will allow the licensed manufacturing and licensed service centers to operate in the unincorporated areas of Umatilla County.

#### **Explanatory Statement**

Oregon voters legalized the supervised use of psilocybin through Ballot Measure 109 (2020) The vote in Umatilla County on Ballot Measure 109 was 11,330 (36%) in favor and 20,126 (64%) in opposition. The Ballot Measure also directs the Oregon Health Authority (OHA) to develop a psilocybin licensing and regulatory program for the state by January 2, 2023. OHA's psilocybin regulatory program is in development. Ballot Measure 109 (2020) allows a local government to adopt an ordinance to be referred to the voters that prohibits the establishment of certain psilocybin-related businesses. The Umatilla County Board of Commissioners has adopted such an ordinance that prohibits psilocybin manufacturers and service centers. This ordinance has been referred to the voters for approval. Approval of this measure would ban the establishment of psilocybin product manufacturers and psilocybin service centers within the unincorporated area of Umatilla County.

A yes vote in favor of this measure will prohibit the psilocybin businesses and will not allow the license manufacturing and licensed service centers to operate in the unincorporated areas of Umatilla County.

A no vote against this measure will allow the licensed manufacturing and licensed service centers to operate in the unincorporated areas of Umatilla County.
