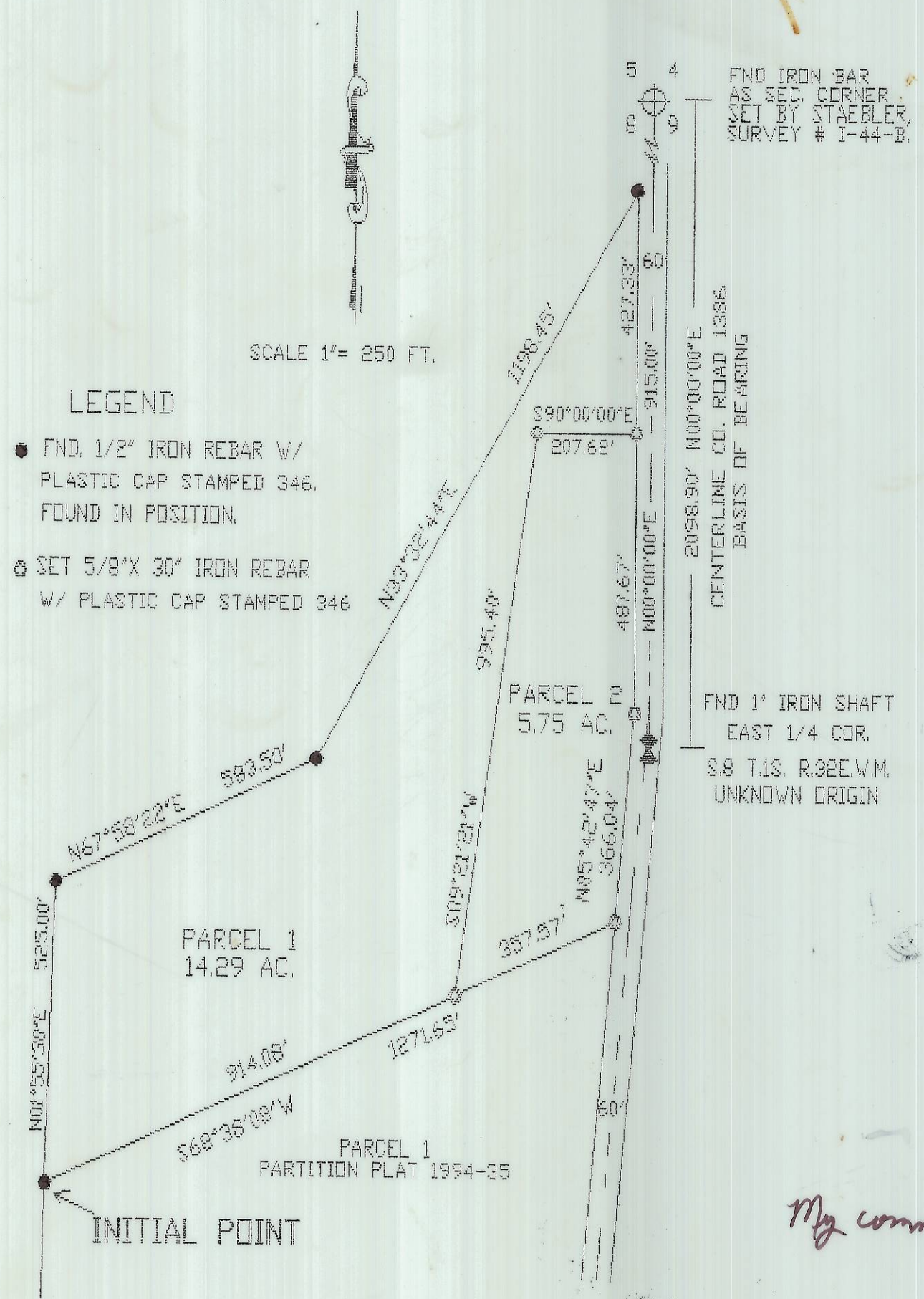

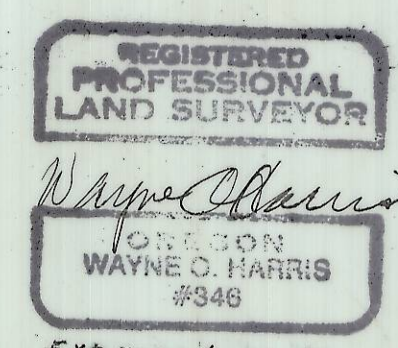

The following correction to said plat is necessary and in accordance with ORS 92.170 I state that the following corrections be made:

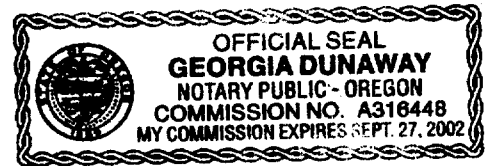
