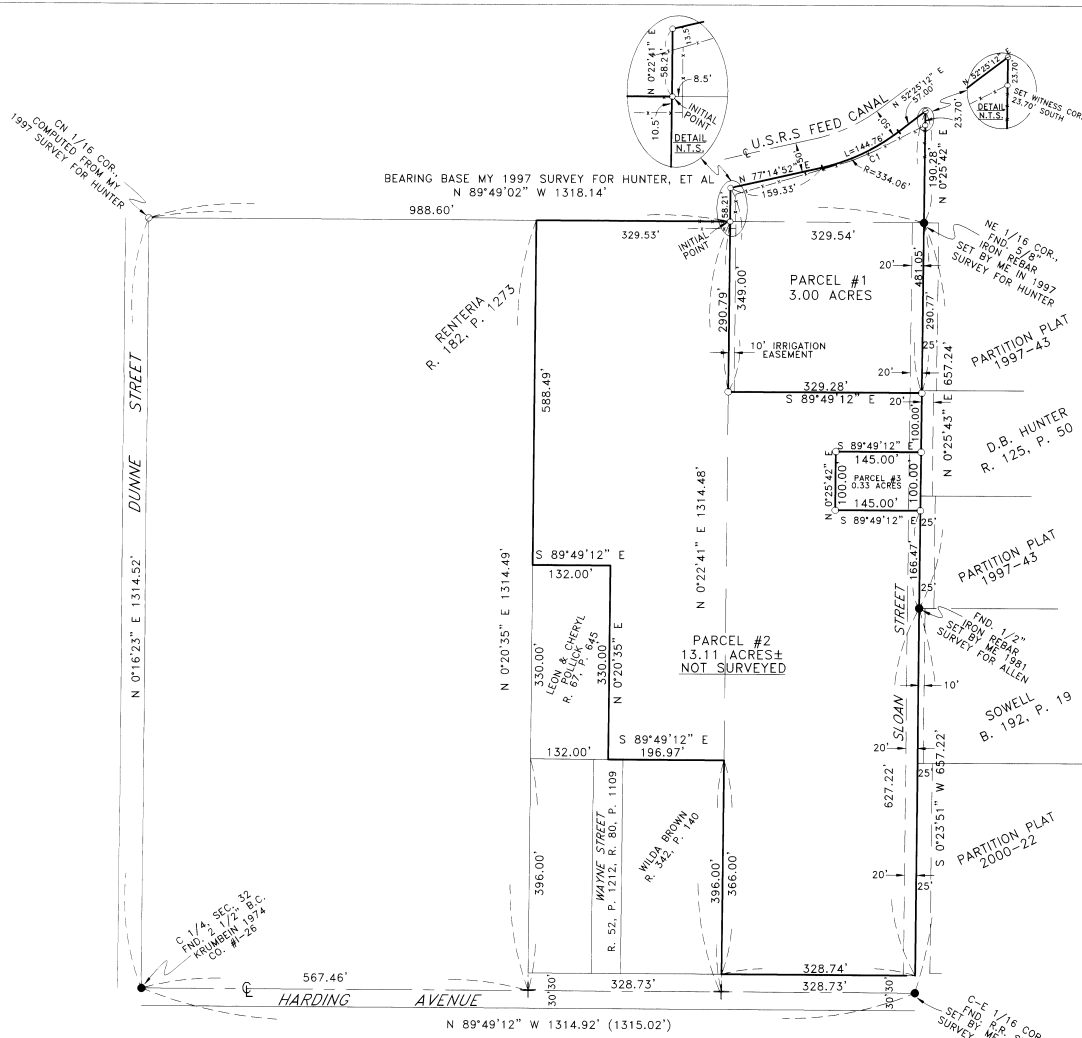

SURVEYOR'S CERTIFICATE:

I, G. DENNIS EDWARDS, AM A REGISTERED SURVEYOR OF THE STATE OF OREGON, AND HAVE MARKED WITH PROPER MONUMENTS THE LAND DESCRIBED BELOW.

I SUBDIVIDED THE NE 1/4 OF THIS SECTION IN A 1997 SURVEY FOR HUNTER AND OTHERS. I BASED THE BEARINGS AND THIS SURVEY ON SAID HUNTER SURVEY.

THE PURPOSE OF THIS SURVEY IS TO PARTITION TWO PARCELS FOR PENDING SALES OUT OF WHAT IS REMAINING OF THAT TRACT OF LAND DEEDED TO CECIL E. AND WILDA A. BROWN RECORDED IN BOOK 271, PAGE 232, UMATILLA COUNTY DEED RECORDS.

I DID NOT SURVEY PARCEL 2.

DESCRIPTION: THAT PORTION OF THE NORTHEAST QUARTER OF SECTION 32, T 4 N, R 29 E, WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON, BEING DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHEAST CORNER OF THE W 1/2 OF THE E 1/2 OF THE SW 1/4 OF SAID SECTION 32 AND RUNNING; THENCE WEST 329.53 FEET TO THE NW CORNER OF SAID W 1/2; THENCE SOUTH ALONG THE WEST LINE OF SAID W 1/2 A DISTANCE OF 588.49 FEET TO THE NW CORNER OF THAT TRACT OF LAND DEEDED TO LEON AND CHERYL POLLICK RECORDED ON REEL 67, PAGE 645, UMATILLA COUNTY DEED RECORDS; THENCE EAST 132.00 FEET TO THE NE CORNER OF SAID POLLICK TRACT; THENCE SOUTH 330.00 FEET TO THE SE CORNER OF SAID POLLICK TRACT; THENCE EAST 196.97 FEET TO THE NE CORNER OF THAT TRACT OF LAND DEEDED TO WILDA BROWN RECORDED ON REEL 342, PAGE 140, UMATILLA COUNTY DEED RECORDS; THENCE SOUTH 366.00 FEET TO THE SE CORNER OF SAID BROWN TRACT. SAID POINT LIES ON THE NORTH RIGHT OF WAY LINE OF HARDING AVENUE; THENCE EAST ALONG SAID NORTH LINE 328.74 FEET TO A POINT ON THE NORTH-SOUTH CENTER LINE OF THE NE 1/4 OF SAID SECTION 32; THENCE NORTH ALONG SAID CENTER LINE 1474.74 FEET TO A POINT ON THE SOUTH RIGHT OF WAY LINE OF THE U.S.R.S. FEED CANAL; THENCE S 52° 25' 12" W ALONG SAID RIGHT OF WAY LINE 57.00 FEET; THENCE CONTINUING ALONG SAID RIGHT OF WAY LINE ALONG A 334.06 FOOT RADIUS CURVE TO THE RIGHT 144.76 (THE CHORD OF WHICH BEARS S 64° 50' 02" W 143.63 FEET); THENCE CONTINUING ALONG SAID RIGHT OF WAY LINE S 77° 14' 52" W 159.23 FEET TO A POINT ON THE EAST LINE OF THE W 1/2 OF THE E 1/2 OF THE NW 1/4 OF THE NE 1/4 OF SAID SECTION 32; THENCE SOUTH 58.21 FEET TO THE POINT OF BEGINNING, CONTAINING 16.44 ACRES, MORE OR LESS.

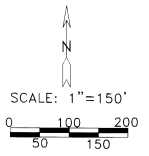
