SURVEYOR'S CERTIFICATE & NARRATIVE:

I, Ronald V. McKinnis, being a Registered Professional Land Surveyor of the State of Oregon, certify that I have correctly surveyed and monumented the land more particularly described in the Legal Description shown hereon according to ORS Chapter 92 of the State of Oregon.
The purpose of this survey was to reconfigure two tracts of land by Partion Replat, Parcel 1 of Partion Plat 2017-10 & Deed 2015-6290339. This Survey is Based on Primm's Survey for Partion Plat 2017-10. The Basis of Bearing for this survey was the Center line of Gettman Road by the pins that Primm set for the South Right of Way. I found the section Corners as indicated along the West Boundary of Section 15 to establish the East Right of Way line of 11th Street (Hwy #207). I reconfigured the two parcel as directed by the owners and as shown on this Partion Plat. The Initial Point for this Survey was my pin set for the Northwest Corner of Parcel 2.
This survey was performed using a Trimble RTK Total Station.

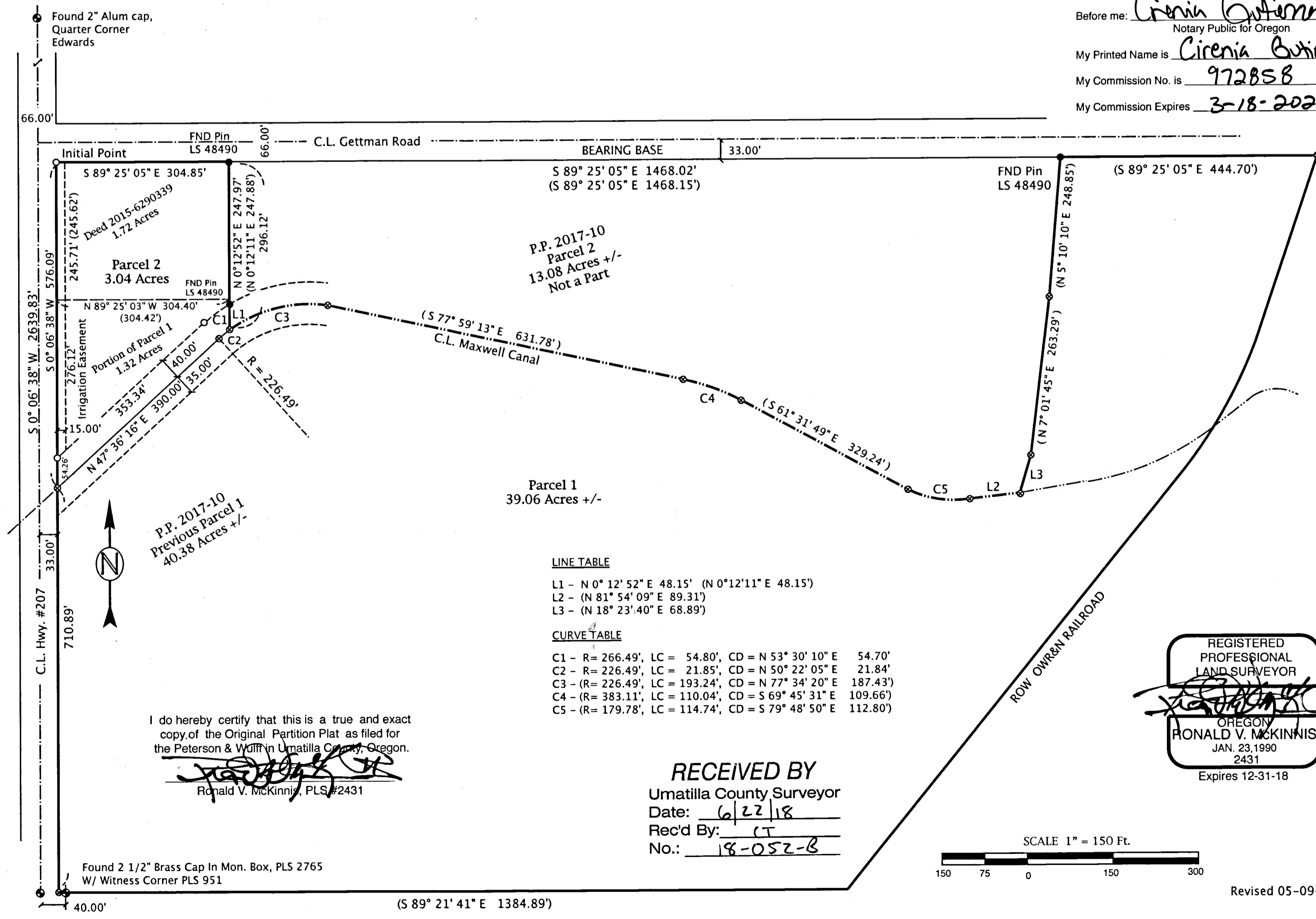

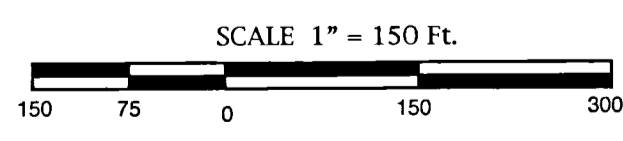
