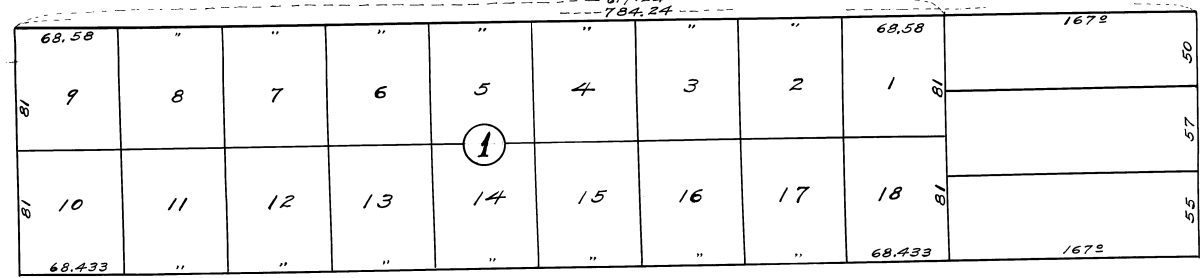
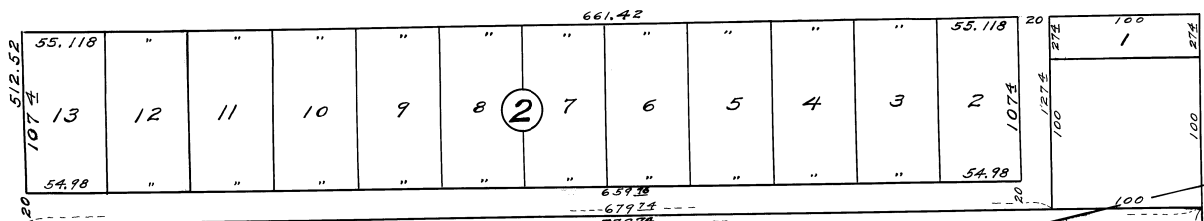

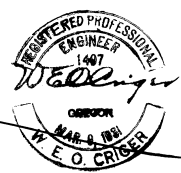

Criger, being duly sworn do testify and say that I have correctly surveyed and platted the land as represented by the accompanying plat, the exterior boundaries of which are described as follows: Beginning at a point on the west line of Evans Street, 162 feet south of the south line of Grant Street, City of Freewater, Oregon; thence southerly on the said West Line of Evans Street 87.2 ft, thence westerly and parallel to the North line of Block 23, 100 ft, thence southerly and parallel to the West line of Evans St, 100 ft, thence westerly and parallel to the North line of said Block 23, 349.8 Feet to the West line of block 23, thence northerly along said west line of Grant St, 61.2 feet, thence southerly and parallel to the West line of Evans Street 162 ft, thence easterly and parallel to the North line of Block 23, 167 feet in a straight line to the point of beginning.
