

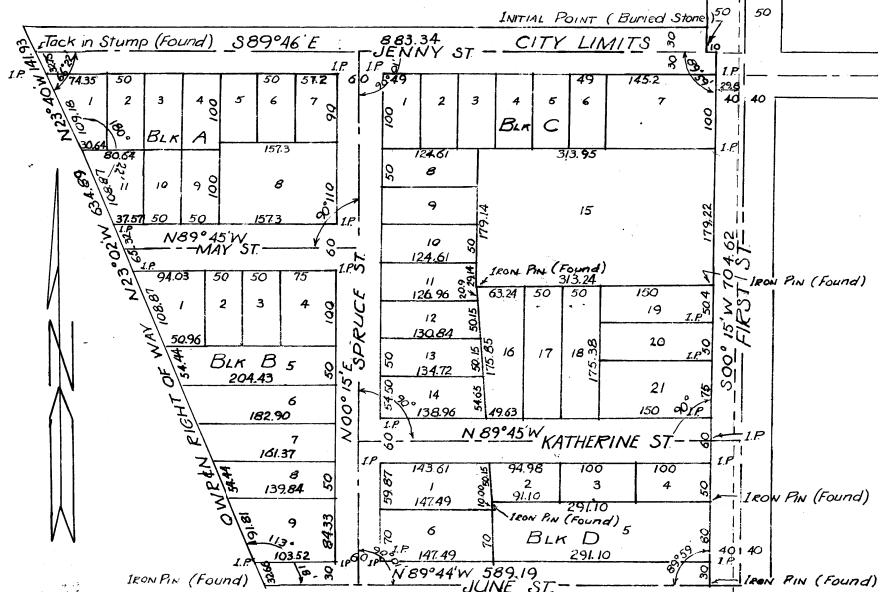
CAMPBELL-TILLER ADDITION

I, George Chicha, being duly sworn, do testify and say I have correctly surveyed and platted the land as represented by the accompanying plat, the exterior boundaries of which are described as follows: Starting from the NE Corner of Sec. 10 T. 4N. R. 28 E. W.M., Umatilla County, State of Oregon, thence N 89° 31' W 42 ft. to a point on the West Right of Way Line of the Umatilla Dam-Hermiston Section of the Old Oregon Trail Highway thence S 00° 15' W along said Right of Way Line 1315.77 ft. to a point on the present City Limits Line of Hermiston which is the Initial Point and is marked by a cross on a stone 12" x 16" x 8" buried 6" under the surface of the ground as per Oregon Code Sec. 19-1304 Annotated; thence S 89° 46' E 10 ft. to the West Line of First Street thence S 00° 15' W 704.62 ft. thence N 89° 44' W 589.19 ft. to the East Right of Way of the O.W.R.&N. Railroad, thence N 23° 02' W 634.89 ft. thence N 23° 40' W 141.93 ft. to a point on the City Limits Line thence S 89° 46' E 883.34 ft. along the City Limits Line to the Initial Point.
