THE PURPOSE OF THIS SURVEY IS TO DO A PROPERTY LINE ADJUSTMENT TO MOVE A PORTION OF THE LOT LINE COMMON TO LOTS 36 AND 37 OF "DESERT OAKS SUBDIVISION" NORTH 5 FEET TO CLEAR A CARPORT AND SHED WHICH ARE ON SAID LOT LINE.

LOT 37 IS A PORTION OF THE PROPERTY DESCRIBED IN A DEED TO WILLAM MILBRODT ON INSTRUMENT 2011-5800790 UMATILLA COUNTY DEED RECORDS AND IS SHOWN AS TAX LOT 19700 ON TAX MAP 4N2816AD. LOT 36 IS DESCRIBED IN A DEED TO DONALD HARING RECORDED ON INSTRUMENT 2011-5810331 UMATILLA COUNTY DEED RECORDS AND IS SHOWN AS TAX LOT 19800.

I FOUND ALL OF THE MONUMENTS OF THESE TWO LOTS AND BASED THE BEARINGS ON THE 2008 PLAT OF "DESERT OAKS SUBDIVISION".

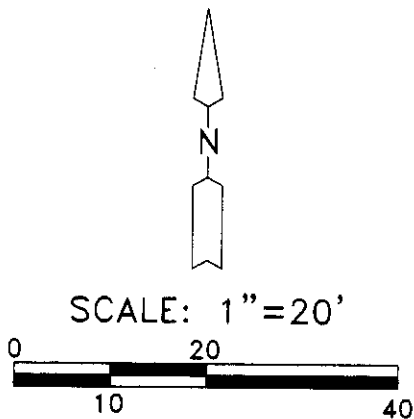
