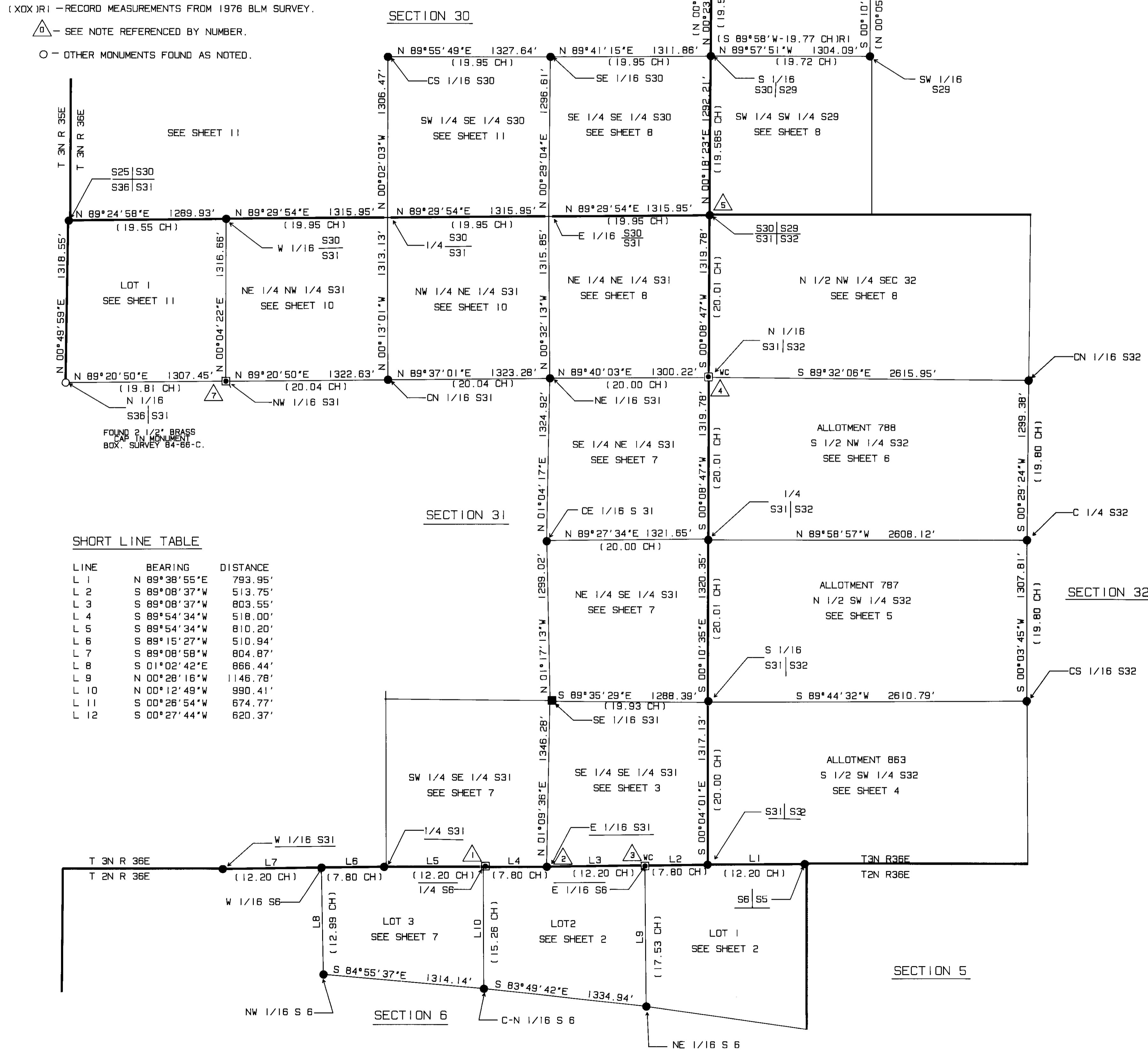
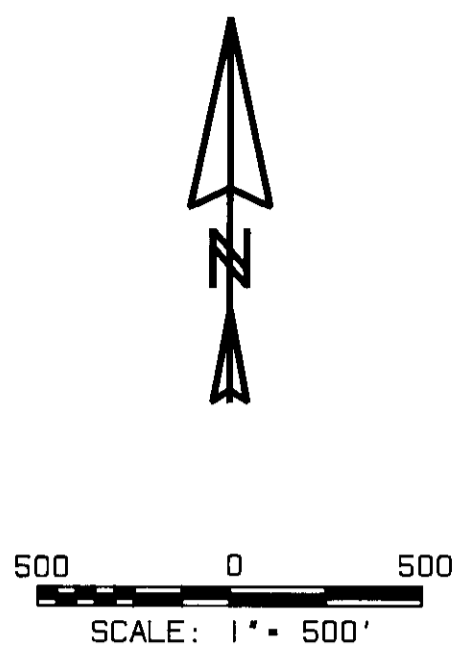

HISTORY OF SURVEYS

THE TOWNSHIP LINE SURVEYS AND SECTION SUBDIVISIONS OF THIS PORTION OF TOWNSHIP 2 AND 3 NORTH, RANGE 36 EAST, W.M., WERE ORIGINALLY MADE BY J.P. CURRIN AND J.E. NOLAND, U.S. DEPUTY SURVEYORS, UNDER SPECIAL INSTRUCTIONS DATED MAY 4, 1887.

IN 1919, C.E. REDFIELD, SURVEYOR FOR THE U.S. INDIAN SERVICE, DEPENDENTLY RETRACED THE EXTERIOR BOUNDARIES OF SECTION 6, TOWNSHIP 2 NORTH, RANGE 36 EAST AND SECTIONS 29, 30, 31 AND 32, TOWNSHIP 3 NORTH, RANGE 36 EAST AND RECOVERED OR RE-ESTABLISHED SECTION AND 1/4 CORNERS. REDFIELD ALSO SUBDIVIDED THE SECTIONS FOR ALLOTMENTS, USING THE "THREE MILE RULE" FOR SECTIONS 29, 30 AND 31. IN SECTION 6 AND SECTION 32, REDFIELD USED A MODIFIED FORM OF THE "THREE MILE RULE" WHEREIN HE ESTABLISHED THE INTERIOR CORNERS BY RUNNING NORTH-SOUTH THROUGH THE SECTIONS. ACCORDING TO REDFIELD'S NOTES, NO INTERIOR SUBDIVISION CORNERS WERE ESTABLISHED IN THE WEST HALF OF SECTION 32. PARTS OF REDFIELD'S FIELD NOTES ARE AVAILABLE IN THE BUREAU OF INDIAN AFFAIRS REALTY SECTION VAULT AT THE UMATILLA AGENCY. THE FIELD NOTES CONSIST OF SEVERAL FIELD BOOKS CONTAINING SURVEYS MADE ON THE RESERVATION. SEVERAL OF THE FIELD BOOKS APPEAR TO BE MISSING AS OF DECEMBER 1988. FIELD NOTE REFERENCES WERE FOUND FOR MOST CORNERS RECOVERED OR RE-ESTABLISHED ON THIS SURVEY.

IN 1976, SECTION 29, TOWNSHIP 3 NORTH, RANGE 36 EAST WAS DEPENDENTLY RESURVEYED AND SUBDIVIDED BY RONALD W. SCHERLER, CADASTRAL SURVEYOR, BUREAU OF LAND MANAGEMENT. COPIES OF THIS SURVEY ARE AVAILABLE IN COUNTY SURVEY RECORDS, IN MICROFILM RECORDS OF GOVERNMENT SURVEYS.

COUNTY SURVEY RECORDS INDICATE SEVERAL OTHER SURVEYS HAVE BEEN MADE IN THE PROJECT AREA. INFORMATION FROM THESE SURVEYS WAS USED WHENEVER APPLICABLE.

NARRATIVE OF SURVEY

THIS SURVEY WAS AUTHORIZED BY THE DEPARTMENT OF NATURAL RESOURCES OF THE CONFEDERATED TRIBES OF THE UMATILLA INDIAN RESERVATION. THE PURPOSE OF THE SURVEY WAS TO RECOVER OR RE-ESTABLISH CERTAIN CORNERS CONTROLLING THE LOCATION OF ALLOTMENTS AND FEE LANDS WHICH WILL BE AFFECTED BY THE CONSTRUCTION OF THE MEACHAM CREEK AND UMATILLA RIVER FISH HABITAT IMPROVEMENTS. DESCRIPTIONS FOR RIGHT-OF-WAYS AND LEASES ACROSS INDIVIDUAL OWNERSHIPS ARE SHOWN ON SEPARATE MAPS.

THE PRESENT SURVEY WAS MADE WITH A 2 PERSON CREW USING A MAC-11-H INFRA-RED DISTANCE METER, WILD T-16 THEODOLITE AND STEEL TAPE. BEARINGS ARE BASED ON SOLAR OBSERVATIONS TAKEN NEAR THE NORTHWEST 1/16 CORNER OF SECTION 6.

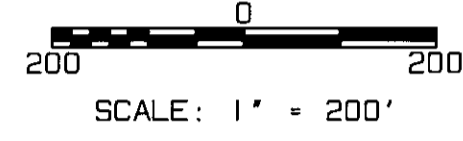
