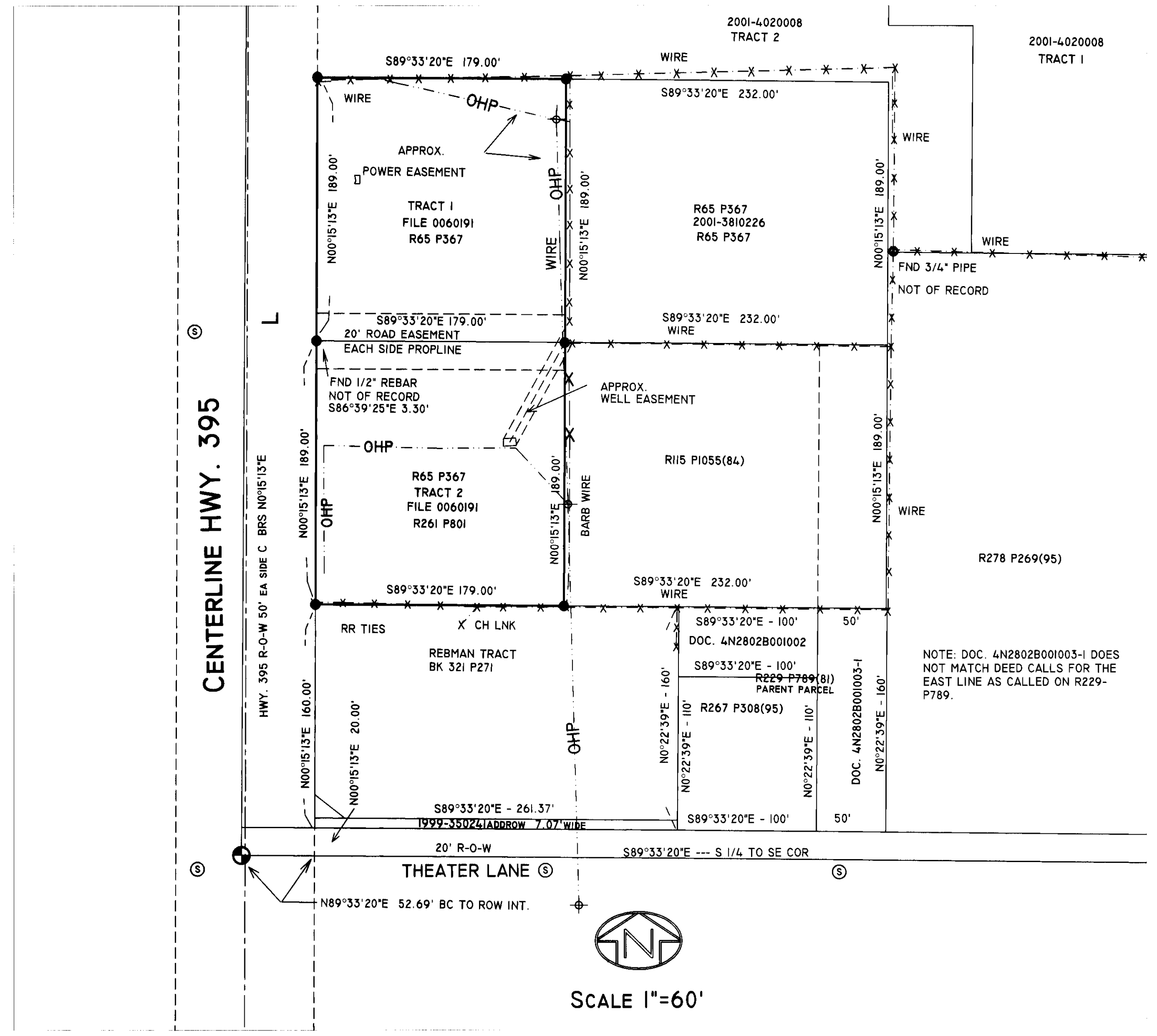
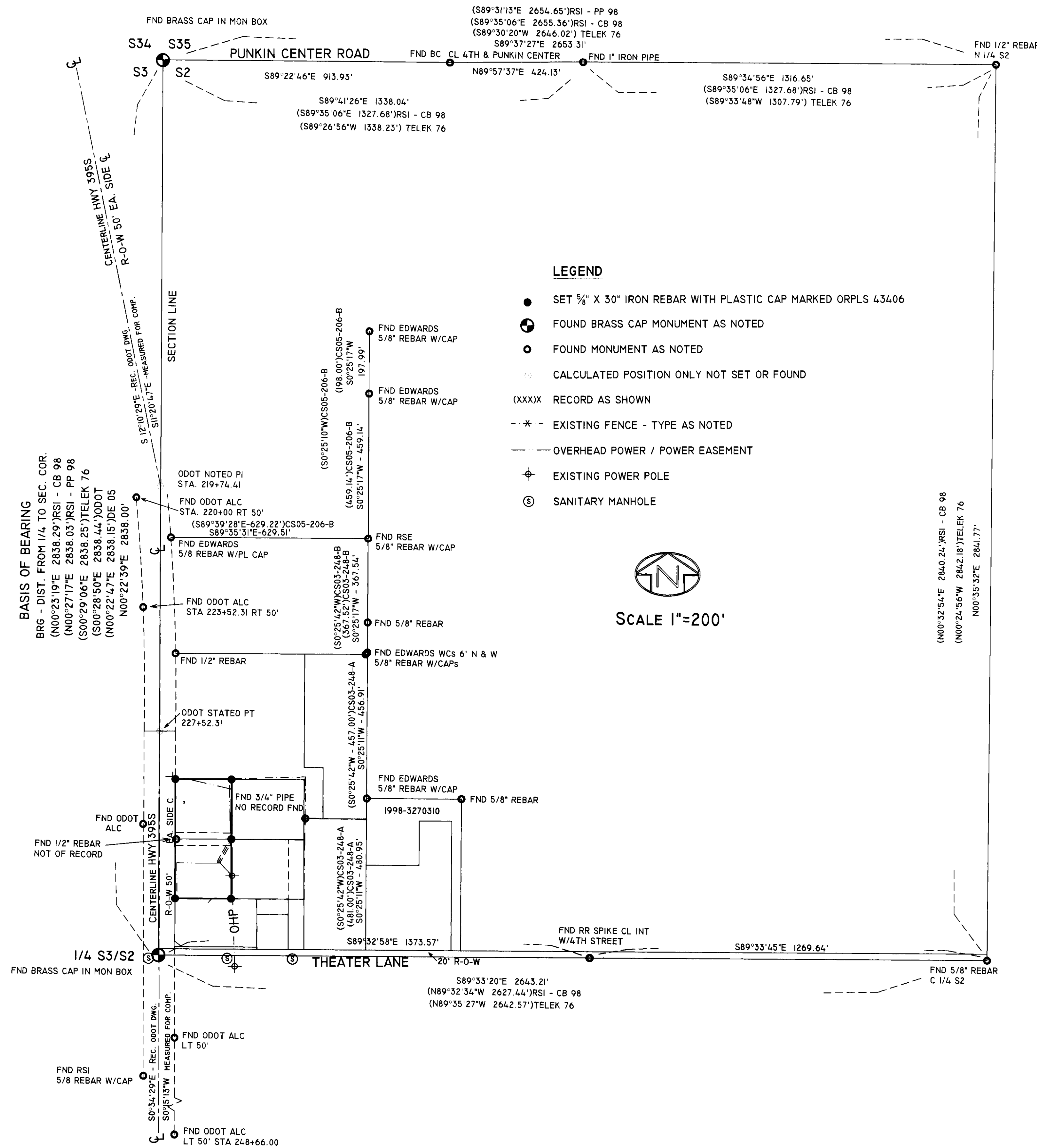

**NARRATIVE OF SURVEY**

THIS SURVEY WAS REQUESTED BY DARREN DICKERHOOF OF DICKERHOOF REAL ESTATE GROUP FOR THE PURPOSE OF MONUMENTING THE CORNERS OF THE PROPERTIES DEPICTED ON THIS DRAWING, AS DESCRIBED BY BARGAIN AND SALE DEED UMATILLA COUNTY RECORDS 2003-4390463 AND 2006-5080154.

I REFERRED TO SEVERAL SURVEYS, AS NOTED, IN THE IMMEDIATE VICINITY. I ALSO USE AN ODOT HIGHWAY 395 RIGHT-OF-WAY MAP WHICH STATED BEARINGS AND STATIONING ALONG SAID HIGHWAY, AND COORDINATES FOR CORNERS TIED DURING THEIR RIGHT-OF-WAY SURVEY INCLUDING TIES TO THE WEST QUARTER CORNER OF SECTION 2 AND THE NORTHWEST CORNER OF SAID SECTION.

FOUND MONUMENTS WERE TIED WITH A SOKKIA GSR2700IS RTK GPS SYSTEM AND THEN UTILIZING REFERENCE DATA FROM "CORPSON" A COMBINED SCALE FACTOR (0.999949332) AND ROTATION FOR CONVERGENCE (0°51'29.43336" CLOCKWISE) WERE APPLIED TO OUR DATA AND COMPARED TO STATED MEASUREMENTS ON OTHER RECORD SURVEYS. ODOT'S DATA WAS PLOTTED AND THEN PLACED OVER OUR SURVEY DATA. I THEN ROTATED THE ODOT INFORMATION TO OUR BEARING BASE ALONG THE WEST LINE OF SECTION 2, WHICH HAS COMPARATIVE TIES. I UTILIZE THIS DATA TO ESTABLISH THE RIGHT-OF-WAY FOR HIGHWAY 395 ALONG THE FRONTAGE OF THE SURVEY PROPERTY. I TIED FENCES AND OTHER IMPROVEMENTS TO THE IMMEDIATE AREA AND ADJOINING PROPERTIES TO USE IN ANALYZING LINES OF OCCUPATION. I SEARCHED FOR SEVERAL OF THE REFERENCED MONUMENTS IN THE ODOT SURVEY. MANY WERE FOUND AND THEIR POSITIONS WERE RELATIVELY CLOSE TO CALLED TIES, MOST BEAR SIGNS OF BEING HIT DURING THE MANY YEARS SINCE THE ODOT SURVEY WAS COMPLETED. I HAVE LISTED THE REFERENCE SURVEY RECORDS ALONG THE SECTIONAL LINES, BECAUSE THERE IS SO MUCH VARIATION, EVEN BY THE SAME SURVEYORS IN A SHORT SPAN OF TIME. I CHOOSE TO HOLD THE ROTATED BEARINGS AND SCALED DISTANCES OF THE OREGON NORTH STATE PLANE SYSTEM, HOLDING THE ODOT TIES FOR POSITIONING OF THE RIGHT-OF-WAY, AND THE DEED CALLS TO THE SOUTH LINE OF THE NORTHWEST QUARTER OF SECTION 2. I LOCATE THE DEED CALLS OF THIS PROPERTY AND ALL OF THE IMMEDIATE ADJOINING PROPERTIES. I THEN COMPARE FENCES AND OBSERVED LINES OF OCCUPATION. I FIND NO RECORDS THAT WOULD INDICATE THAT THIS PROPERTY WAS EVER SURVEYED, AND RECORDED. I FIND ENOUGH EVIDENCE FROM THE ODOT SURVEY AND OTHER FOUND EVIDENCE, OR WHAT APPEARS TO BE AN EVIDENCE, AND FENCE LINES IN THIS IMMEDIATE AREA THAT ARE VERY CLOSE TO CALCULATED DEED LINES THAT IT WOULD BE COINCIDENTAL IF IT WERE NEVER SURVEYED. I SUSPECT THAT MANY WERE SURVEYED PRIOR TO THE RECORDING LAWS GOING INTO EFFECT, AND NEVER RECORDED.

I FIND NOTHING UNUSUAL, OUTSIDE OF ITEMS STATED IN THIS NARRATIVE, AND DEED LINES WERE MONUMENTED AS SHOWN IN THIS RECORD OF SURVEY.
