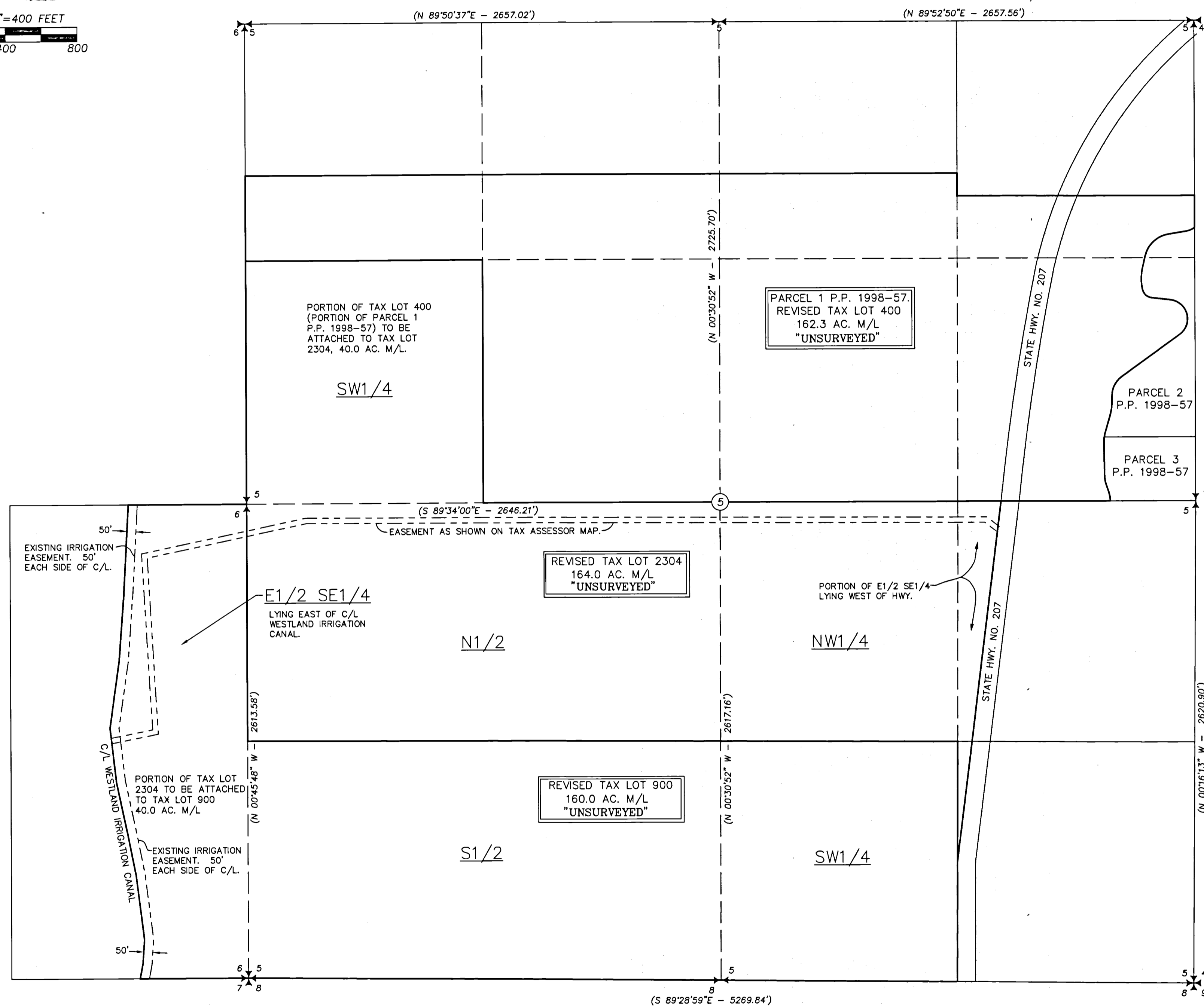

I DID NOT SURVEY ANY PORTION OF THE TRACTS INVOLVED IN THIS PROPERTY LINE ADJUSTMENT AS THEY ARE ALL LARGER THAN 10 ACRES MINIMUM SIZE PER UMATILLA COUNTY ORDINANCES. THE PROPERTY DESCRIPTIONS WERE OBTAINED FROM PRELIMINARY REPORT FOR TITLE INSURANCE, BY PIONEER TITLE COMPANY, ORDER NO. 97680, DATED APRIL 6, 2018. NO MONUMENTS WERE SEARCHED FOR, SET, OR TIED ON THIS PROPERTY LINE ADJUSTMENT. NOT ALL EASEMENTS AND ENCUMBRANCES ARE SHOWN. OTHER RECORD EASEMENTS AND ENCUMBRANCES EXIST.
