Holmi, Umatilla Co. Or. Nov. 27th 1888

To the Hon. County Court, Umatilla County, Oregon.

We, the undersigned, your appointed viewers on Road Survey No. 314, would respectfully report that we met County Surveyor, Jno. C. Arnold, at time & place appointed for the same; & calling to our aid Elias Stavel to act as marker, & Monroe Jarvis & Frank A. Newman to act as chain bearers, each of whom, as well as ourselves, being duly qualified as required by law, we proceeded to view out & survey said road as prayed for in the petition for same.

We find the road located upon good ground; the grade out from the Umatilla River northward is easy, & the principal part of the grading already done, the road is greatly needed & is now already traveled to a great extent.

We, therefore, recommend that said Road 314 become a public road & that the prayer of the petitioners be granted.

Field Notes of Road Survey No. 314 for U. Co. Ch.

I met N. Daughtrey & W^m Fraker viewers on Road Survey No. 314, at Holmi, Umatilla Co., Oregon on Monday Nov. 26th 1888 who were qualified as the law requires.

We called J. M. Jarvis & F. A. Newman to act as chain bearers, & Elias Stavel to act as marker who were qualified, each, according to law.

Jno. S. Union & F. A. Newman identify the locality for 1/4 S. Cor. bet Secs. 5 & 6 T. 2. N. R. 30. E. (Original mound & post, gone & corner & corner obliterated.)

I set initial post 75 links west of point for 1/4 S. Cor. as described, & run to cross track of O. R. & N. R. R.
