Road leading from Helix to Vanrycle where it crosses the line between the NE<sup>1/4</sup> & SE<sup>1/4</sup> of Sec 21 Tp. 5 N. R. 33 E. about 20 rods from N.E. Cor. S. E<sup>1/4</sup> Sec. 21 Tp. 5 N. R. 33 E. Running Westerly to intersect County Road leading to Vanrycle at or near N.W. Corner S.W<sup>1/4</sup> Sec. 20 Tp. 5 N. R. 33 E.

- Viewers Report. -

To the Hon County Court

Umatilla County, Oregon; -

We, the undersigned, viewers on road survey No. 318, would respectfully report that we met County Surveyor Jas. C. Arnold at the time & place appointed for the same, & calling to our aid Jas. M<sup>c</sup> Ewen & L. B. Jay, we proceeded to view out & survey said road as prayed for in petition for the same

We find the road much needed as an outlet to R. R. stations, & on a practicable route, & therefore recommend that said road 318 become a public highway.

- Field Notes -

Field Notes of Road Survey No. 318, for Umatilla County, Oregon.

I met W. C. Kern, W<sup>m</sup> Scott & John Caplinger, viewers, on road survey No. 318, at Helix, March 22<sup>d</sup> 1889. I administered usual form of road viewers oath to each; after which, we called to our assistance L. B. Jay & Jas M<sup>c</sup> Ewen, to carry the chain & L. B. Jay to mark, who were, each, sworn in the usual manner.

I set initial post 29 links South of intersection of Road No. 313 with the line E & W through the center of Sec. 21 & against fence on East side of said road 313, from which the 1<sup>st</sup> mile post bears S. 12° W. 200 links distant.

- From said point of intersection I run West on  $\frac{1}{2}$  Sec line
- chs. .50 Ascend hill
- 3.00 Summit; Descend
- 6.00 Ravine -  $\frac{1}{2}$  runs N. Ascend
- 10.00 Summit. Ascend.
- 13.00 Set Angle Stake 45 links South of Pt & turn left 37°
- 17.00 Set Angle Stake 45 links South of Pt & turn right 75° Ascend
- 21.00 Set Angle Stake 45 links South of Pt & turn left, along  $\frac{1}{2}$  Sec line, 36°
- 27.50 Ravine -  $\frac{1}{2}$ ; Course N. Ascend
- 31.00 Summit; Descend.
- 33.60 Ravine - 6, runs N. E. at Jas. M<sup>c</sup> Ewen's Res. Ascend.
- 45.25 Summit, Descend.
