Done by Wm. Kern W. M. Deatt and John Caplinger
viewers on Road Survey No 328 for Multnomah
County Or, at Multnomah in said County June 19th
A.D. 1889 at 9 o'clock Am.

I administered the usual oath of Road-viewers
to each after which we called A. S. Rest & Galloway
to chain and A. S. Rest to mark, who were each
qualified as required by law

I commence Road No 328 at the 1/4 Sec corner
Sec 23 & 26 in T 5 N R 33 E. the initial post
is set 50 links N.E. of said cor so as to be out
of way of travel on this road. From said
1/4 Sec cor I run on line bet Secs 23 & 26 as
