TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON, FOR UMATILLA COUNTY  
WE, THE UNDERSIGNED, Board of County road viewers, heretofore instructed to  
view, survey, and locate Road No 570, submit the following report:

Pursuant to an order of the Honorable County Court, we met at County Surveyors  
Office in Court House in Pendleton, on the 13th day of April, 1905.

Surveyor each duly sworn. We viewed, surveyed, and located said Road No. 570, as  
specified in our order. We find said route practicable; indispensable to the neigh-  
borhood, and public generally; that the lands of Martin Markeson, the SW 1/4 of Se  
1/4 Sec. 11, the lands of Henry rath, the SE 1/4 of SE 1/4 of Sec. 11, and the lands  
of the heirs of Louis Neil, deceased, to-wit: the NW 1/4 of NE 1/4 Sec. 14, that the  
lands of Frank Whitem, to-wit: The NW 1/4 Sec. 13, that the lands of ChalRes White  
to-wit: The NE 1/4 of Sec. 13, that the claimed lands of Fred Hill, to-wit: The  
S 1/2 of the S 1/2 of sec. 12 all above lands being situated in T 2 N R 31, E W M,  
Oregon, would not be rendered less valuable by the location of said road No. 570, but  
each and all of them would be benefited by said location of said road; that the lands  
of Gus. Hill of the Hill estate, to-wit: The SW 1/4 of SW 1/4 of Sec. 7 T 2 N R 32,  
E would not be rendered less valuable by location of said road No. 570;

We therefore most respectfully recommend the same be declared a public highway  
of Umatilla County, Oregon.
