REPORT OF BOARD OF COUNTY ROAD VIEWERS.

In the Matter of vieweing, surveying and laying out county road to vacate in T 5 N R 28 E W M To the Honorable county court of the State of Oregon for Umatilla county.

We, the undersigned board of conty road viewers, heretofore instructed to view, survey and locate road to vacate, submit the following report:

Pursuant to an order of the Honorable county court, we met at the commencement of said road on the 26th day of January 1910. We called to our aid W. J. Stockman, chairman, H. G. Covey, chairman; J H Saling, flagman, Sam Williams, mar er. who were by the surveyor each duly sworn, we viewed, surveyed and located said road to vacate as specified in our order. We find said route to be unnecessary for the use of the public as a highway. we therefore most respectfully recommend the same be vacated and abandoned as a public highway.
