

Petition for a County Road
To The Honorable, The County Court
of Umatilla County, State of Oregon
We the undersigned Citizens
and Resident Householders of Umatilla
County, State of Oregon, and living
in the vicinity of the hereinafter
Proposed County Road in and for
Said County and State, would respectfully
petition your Honorable
Court at your January term thereof
A.D. 1883 to grant a view and survey
for a County Road, as follows, to wit:

Commencing at what is known as
the Deer Spring Road, on top of the
hill near $\frac{1}{4}$ mile East of the S.W. cor-
ner of Section 36, in Township 6 N of
R. 34 E, in the Willamette Meridian,
Thence N $\frac{3}{4}$ of a mile on the line the
w. the center of the S.W. and N.W. quar-
ters of said Section ³⁶, Thence E until
it crosses Dry Creek below Sam John-
sons Orchard, Thence N.E. until
it intersects ^{said} Section 30 ^{at or near the}
S.W. corner of ^{Section 30} Township 6 N of R. 34 E,
Thence due N. on the Township line
to the State line between the State
of Oregon and Washington Territory

thence E. 2 miles on the S. side of the line between the State of Oregon and Washington Territory to the fractional N.W. corner of Section 16.

And your Petitioners therefore most respectfully ask your honorable Court to cause such legal proceedings to be had as to cause said route to be viewed, surveyed, and declared a Public highway.

And your Petitioners therefore as in duty bound will ever pray.
