twenty three thence South along Sec Line  
to South East corner of Sec (23) thence  
East along Sec Line two miles & three fourths  
thence Due South one Half mile thence East  
one fourth mile to East Line of Section  
(29) twenty nine, Township (6) Six North  
Range (35) East thence South three  
fourths of one mile thence East one Half  
mile thence South one fourth mile to the  
Center of Section (33) T (6), N. R. (35) &c

 along the Land known as the old Blalock

 line running North and South through Sec  
 (34) thence South to the Line of O.R.N.  
 Co R.R Land thence Easterly along  
 the Line of said RR to an intersection  
 with a County Road Leading from  
 State Line to Milton Oregon in Sec (3)  
 three Township (5) North Range (35) East
