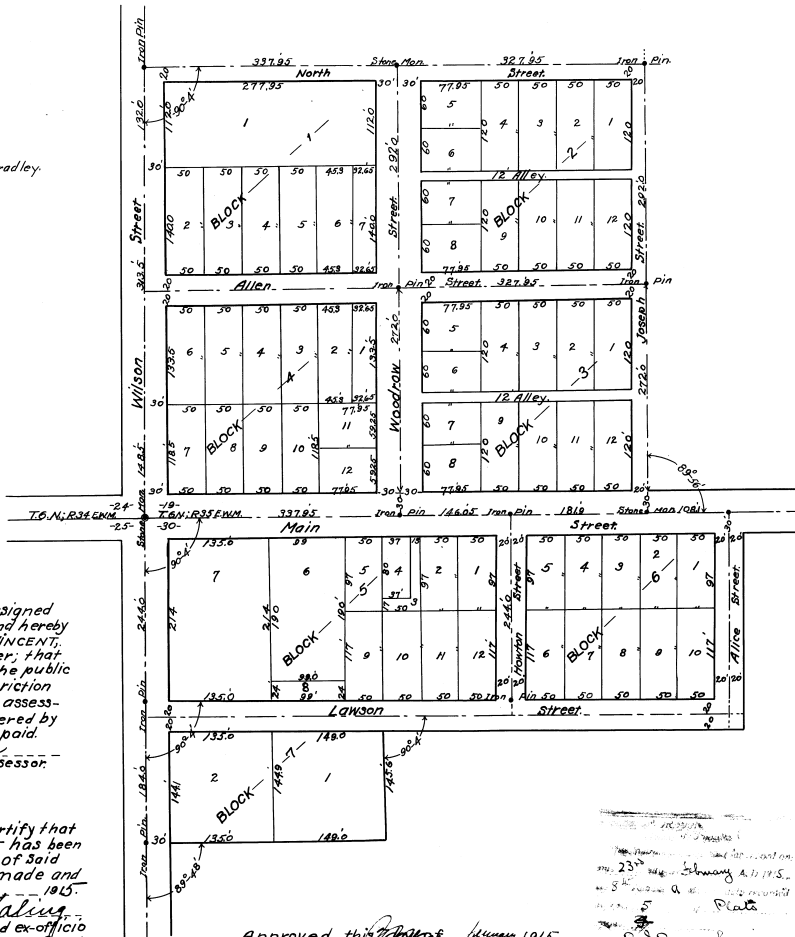
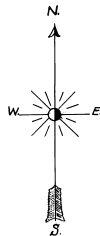


MAP
