

To the honorable County Court of

Your Petitioners, house holders & Free
holders in the vicinity of said Road
do most respectfully request your
honorable body to grant us the fol-
lowing described route, forty feet wide,
for a Public Highway as follows, to wit:
Commencing at a point on a newly
proposed County Road, at the North
East corner of the North west quarter of
the North west quarter of section twen-
tyone (21) in Township six (6) North
of Range thirtyfive (35) East in said
County of Umatilla and State of Oregon
Thence East on the line between sections
sixteen (16) and twentyone (21) in said
Township, to the North East corner of the
North west quarter of said section twenty
one (21), Thence South one fourth ($\frac{1}{4}$) of a mile
Thence East thro' the Centre of the North
East quarter of said section twentyone
(21) to the intersection of the line running
North & South between sections twentyone
(21) and twentytwo (22) in said Township
Thence South on said line to the corners
to sections twentyone (21) twentytwo (22)
twentyseven (27) and twentyeight (28) in
in said Township, Thence East on the

line between sections twenty two (22) and twenty seven (27) one fourth ($\frac{1}{4}$) of a mile, Thence South on or as near the line as the ground will admit of through the centre of the North west quarter of said section twenty seven (27) to the intersection of the line running East and west between the North west & South west quarters of said section twenty seven (27) in said Township. Thence a South Eastwardly direction so as to pass on the west line of John Ostrutay land in said Township. Thence a South Eastwardly direction so as to intersect the Walla Walla and Weston Road near the school house. On section One (1) in Township Five (5) North of Range thirty five (35) East in said County

And your Petitioners most respectfully request your honorable body to cause such legal proceedings to be had as to cause said route to be viewed and surveyed according to law, and to be declared a Public Highway, And your Petitioners therefore as in duty bound will ever
