WHEREAS a portion of County Road No. 541 (also known as North Main), is located within the limits of the City of Milton-Freewater;

WHEREAS pursuant to ORS 373.270 jurisdiction over a County Road within a city may be transferred to the city from the county when the county governing body deems its necessary, expedient or for the best interest of the county to surrender jurisdiction over the County Road, or a portion of it, within the corporate limits of any city, and the city governing body deems it necessary, expedient or for the best interests of the city to acquire jurisdiction to the same extent as it has over other city public streets;

WHEREAS on April 24, 2005, a hearing was held before the City Council of the City of Milton-Freewater to consider the transfer of the jurisdiction of County Road No. 541 from its intersection with NE 8th Avenue to its intersection with Powell Road (approximately .5 mile length) inside the city limits of the City of Milton-Freewater;

WHEREAS the City Council of the City of Milton-Freewater found that it would be in the best interest of both the County and the City to transfer jurisdiction, agreed that the full and absolute jurisdiction over the section of road for all purposes vest in the City, and signed an Intergovernmental Agreement for the transfer of the section of roadway without any limitation, a copy of which is attached to this order;

WHEREAS the Board of Commissioners finds it to be in the best interest of the County to surrender jurisdiction over the portion of County Road No. 541 lying within the corporate limits of the City to Milton-Freewater, to the City.

NOW THEREFORE IT IS ORDERED pursuant to ORS 383.270(6)(b), that jurisdiction over the portion of County Road No. 541 between NE 8th Avenue and Powell Road, is surrendered to the City of Milton-Freewater, and the full and absolute jurisdiction over the road for all purposes is now vested in the City of Milton-Freewater.

**INTERGOVERNMENTAL AGREEMENT BETWEEN UMATILLA COUNTY AND THE CITY OF MILTON-FREEWATER REGARDING THE JURISDICTION TRANSFER OF A SECTION OF ROADWAY**

WHEREAS, the City Council of the City of Milton-Freewater and the County Commissioners of the County of Umatilla, both agree that the transfer of jurisdiction of a .5 mile length section of roadway known as North Main Street from the intersection of NE 8<sup>th</sup> Avenue to the intersection of Powell Road inside the city limits of the City of Milton-Freewater, Oregon.

WHEREAS, the County Commissioners of the County of Umatilla and the City Council of the City of Milton-Freewater agree the transfer of jurisdiction of said roadway would be from the County to the City.

WHEREAS, an opportunity for public input was hosted by the City Council of the City of Milton-Freewater at their regularly scheduled business meeting held April 24, 2006 in the Albee Room of the public library in Milton-Freewater.

WHEREAS, after hosting such an opportunity, and consideration by the City Council at said meeting, it was determined that the jurisdictional transfer would be in the best interest of both the County and the City.

THEREFORE, it is hereby agreed by both the parties that jurisdiction over the above described portion of County road shall be transferred to the City of Milton-Freewater, Oregon and that full and absolute jurisdiction over the section of road for all purposes shall vest in the City.

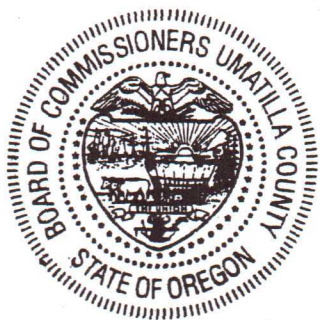
