ORDER NO. RD2006-04

WHEREAS, the Umatilla County Board of Commissioners may, under authority of ORS 368.201 to 368.221, order county roads that have been used and traveled by the public for ten (10) years or more to be surveyed and recorded, and

WHEREAS, the Umatilla County Board of Commissioners ordered the survey of Hood Road, County Road No. 550, lying in Sections 14, 15, 22, and 23, Township 6 North, Range 36 E.W.M., between Birch Creek Road and the Oregon-Washington State Line, and

WHEREAS, the Notice of Hearing was posted and all owners of abutting property affected by the legalization procedure were served copies of the Notice of Hearing, and

WHEREAS, the Umatilla County Board of Commissioners on March 15, 2006, held a public hearing and finding that it would be in the public interest to legalize the road:

THEREFORE IT IS NOW ORDERED that the road be legalized as follows:

A 40-foot wide strip of land for road and utility installation purposes located in Sections 14, 15, 22, and 23, Township 6 North, Range 36 East of the Willamette Meridian lying 20 feet on each side of the following described centerline:

Beginning at a railroad spike marking the Corner common to Sections 22, 23, 26, and 27, T. 6 N., Range 36 E.W.M.; thence N02°01'45"W, 520.41 feet to a railroad spike; thence N01°53'10"W, 423.31 feet to a railroad spike; thence N01°33'38"W, 373.18 feet to a railroad spike; thence N01°27'44"W, 396.38 feet to a railroad spike; thence N01°35'54"W, 399.50 feet to a railroad spike; thence N01°35'57"W, 395.11 feet to a railroad spike which bears S02°57'36"W, 132.40 feet from a 5/8" steel rebar with 2" aluminum cap marking the 1/4 Corner common to Sections 22 and 23, T. 6 N., Range 36 E.W.M.; thence N01°30'11"W, 396.88 feet to a railroad spike; thence N01°18'06"W, 403.47 feet to a railroad spike; thence N01°02'14"W, 398.13 feet to a railroad spike; thence N01°26'58"W, 409.77 feet to a railroad spike; thence N01°21'41"W, 404.60 feet to a railroad spike; thence N01°06'38"W, 391.77 feet to a railroad spike; thence N01°03'32"W, 367.29 feet to a 2" brass disk marking the Corner common to Sections 14, 15, 22, and 23, T. 6 N., Range 36 E.W.M.; thence N01°42'12"W, 432.77 feet to a railroad spike; thence N00°55'58"W, 407.82 feet to a railroad spike; thence N01°22'21"W, 440.40 feet to a railroad spike; thence N01°17'48"W, 406.94 feet to a railroad spike; thence N01°00'50"W, 395.67 feet to a railroad spike; thence N00°51'34"W, 322.55 feet to a railroad spike; thence N00°30'37"W, 461.46 feet to a railroad spike which bears N02°51'35"W, 229.72 feet from a 5/8" steel rebar with 2" aluminum cap marking the 1/4 Corner common to Sections 14 and 15, T. 6 N., Range 36 E.W.M.; thence N00°37'47"W, 246.40 feet to a railroad spike; thence N00°37'47"W, 274.34 feet; thence 109.60 feet along a 69.38-foot

radius curve right (the long chord bears N44°37'33"E, 98.55 feet) to a point which bears N76°23'26"E, 67.28 feet from a brass-capped monument marking the Closing Corner on the Oregon-Washington State Line common to Sections 14 and 15, T. 6 N., Range 36 E.W.M. and there terminating. EXCEPTING THEREFROM that portion of the above described road lying north of the Oregon-Washington State Line. Bearings and distances are NAD '83('91) grid. The plat of the above described road is recorded as Survey No. 05-178-C in the Umatilla County Surveyor's Office.
