WITNESSETH: That the said Grantors, for and in consideration of the
acceptance thereof by the Grantee for the purposes hereinafter mention-
ed and set forth, have granted, bargined, sold and delivered, and by these
presents do hereby grant, bargain, sell, convey and forever quit-claim
unto the said Grantee the following described lands to be used as a
public right-of-way and for no other purpose whatsoever, to-wit:

Beginning at a point Twenty (20) feet North of the South-east
corner of the North-east One Quarter (1/4) of Section Thirty-six, in
Township Six (6), North, Range Thirty-five (35), East, in Umatilla County,
Oregon, this said point being located upon a regularly laid out County
Road, running thence West on a line parallel to the East and West center
section line of this said Section Thirty-six (36), and Twenty (20) feet
distant therefrom unto a point Twenty (20) feet North of the center of
this said Section Thirty-six (36), thence South Forty (40) feet to a
point Twenty (20) feet South of this said center of this said Section,
thence East on a line parallel to the aforesaid East and West center
section line and Twenty (20) feet therefrom, to a point Forty (40) feet
South of the point of beginning, thence North to the point of beginning,

Together with all and singular the tenements, hereditaments and
appurtenances thereunto belonging or in any wise appertaining, and also
all their right, title and interest in and to the same:

TO HAVE AND TO HOLD THE SAME, with their appurtenances, unto the said Grantee forever, PROVIDED this said Grantee shall immediately order the same, and the whole thereof, or so much as is not at this time a County Road, opened as a County Road, and shall maintain the same as such forever.
