Know all men by these presents, That W. H. Coghill and Amy Coghill, husband and wife,

of the County of Umatilla

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid to them, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in (the State of Oregon, to-wit:) A strip of land Sixty (60) feet wide, being Thirty (30) feet on

each side of the center line of said road, as surveyed over and across the Northeast Quarter of the Northeast Quarter of Section 12, T. 5 N. R. 35 E. W.M. Said center line being more particularly described as follows: Beginning at a point on the section line between Sections 1 and 12, said point being 64 feet east of the Northwest corner of the Northeast Quarter of the Northeast Quarter of Section 12, thence on a 240.5 feet radius curve to the left, the tangent of which at the point of beginning is the above mentioned section line, adistance of 287.5 feet, thence South 21° 00' West, 645.9 feet, thence on a 359.3 feet radius curve to the left, 215.0 feet, thence South 14° 24' East, 265.0 feet to a point which is 1225 feet South and 388 feet West of the Northwest corner of the Northeast Quarter of the Northeast Quarter of Section 12.
