Known as the EAST SIDE Highway

Know all men by these presents, That L. Heidenrich and Cora Heidenrich, his wife,

of the County of Umatilla

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid them, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across from Station 0 + 10 to Station 0 + 75, a strip of land Forty (40) feet wide, being Twenty (20) feet wide on each side of the center line of said road from Station 0 + 75 to Station 1 + 50, a strip of land Sixty (60) feet wide, being Thirty (30) feet wide on each side of the center line of said road over and across a portion

of Section 25 Township 6 North Range 35 East W. M. Beginning at Station 0 + 10 of the East Side Highway Survey which Station is approximately 21 feet south and 1564 feet east of the quarter Corner which is common to Sections 24 and 25 Township 6 North Range 35 East W. M. Thence running in a southerly direction approximately 480 feet to Station 4 + 90 of the said survey, which Station is approximately 466 feet south and 1614 feet east of the quarter corner which is common to Sections 24 and 25 Township 6 North Range 35 East W. M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
