BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, That THE UNDERSIGNED

_____, hereinafter called **Grantor**, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto the COUNTY OF UMATILLA, by and through its DEPARTMENT OF PUBLIC WORKS, hereinafter called **Grantee**, and unto Grantee's successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Umatilla, State of Oregon, described as follows, to wit:

Beginning at a point 15.69 feet North and 765.43 feet East of the West 1/4 corner of Section 22, Township 5 North, Range 36 E.W.M.; Thence on a 1233.24 foot radius curve left (the long chord of which bears N37°30'16"E and 106.52 foot distance) 106.55 feet; Thence N86°49'25"E 99.98 feet; Thence on a 1313.24 foot radius curve right (the long chord of which bears S35°19'58"W and 137.10 foot distance) 137.16 feet; Thence N75°40'19"W 88.13 feet, to the point of beginning for this description.

The parcel of land to which this description applies contains 0.22 acres, more or less.

To Have and to Hold the same unto the said Grantee and Grantee's successors and assigns forever.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 1.00 . However, the actual consideration consists of or includes other property or value given or promised which is part of the consideration

Also for the above stated consideration, ^{there} ~~it~~ is hereby conveyed to Grantee all existing, future or potential common law or statutory abutter's easements of access between the right of way of the public way identified as the relocated Dorothy Bridge and all of Grantor's remaining real property.

Grantee shall provide access on the Westerly side of the road, and Grantors, their heirs and assigns, shall be entitled to reasonable access to said road for any purpose upon application filed with Grantee pursuant to applicable statutes and regulations. Said road shall be connected to the main road or to other public ways only at such places as Grantee may select.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.



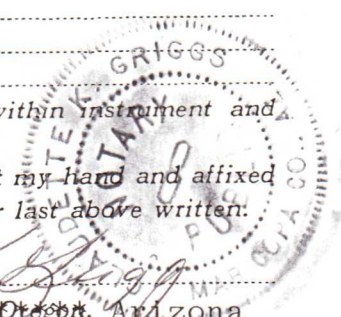
