

RIGHT-OF-WAY DEED

IN THE MATTER OF OREGON ROAD, Known as the
Oregon-Washington Highway

KNOW ALL MEN BY THESE PRESENTS, That D.H.Wilsey and Hattie Wilsey, his wife and Lester D.Wilsey, unmarried of the County of Umatilla in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of Eleven Hundred Fifteen (\$1115.00) Dollars, paid them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the county of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit:

All that party of the property of D.H.Wilsey and Hattie Wilsey and Lester D.Wilsey in the E 1/2 of SE 1/4 of Sec.15 and the W 1/2 of the SW 1/4 of Sec. 14, T. 4 N.R. 35 E.W.M. included within a strip of land 60 feet in width, being 30 feet on each side of the center line of the Oregon- Washington Highway No. 8 as surveyed over and across said property and more particularly described as follows: Beginning at a point approximately 1767.0 feet North and 1380.0 feet East of the 1/4 section corner between Sections 15 and 22, T. 4 N.R. 35 E.W.M., Umatilla County, State of Oregon; thence N. 57°47' E. 1407.5 feet; to a point approximately 463.0 feet East of the 1/4 sec. corner between sections 14 and 15, T. 4 N.R. 35 E.W.M., said tract of land containing 2.63 acres of land more or less.

TO HAVE AND TO HOLD the same, unto the County of Umatilla, State of Oregon, for the purposes of a public road forever.
