## RELINQUISHMENT OF TITLE

KNOW ALL MEN BY THESE PRESENTS, That the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, Highway Division, hereby relinquishes and conveys unto UMATILLA COUNTY, a political subdivision of the State of Oregon, its right, title and interest in and to the following described property, only so long as used for public road purposes, to wit:

That certain real property consisting of 4 parts situated in Sections 2 and 11, Township 4 North, Range 35 East, W.M. and in Sections 13 and 14, Township 5 North, Range 35 East, W.M., Umatilla County, Oregon.

Part 1 being that property described in that deed to the State of Oregon, recorded in Book 130, Page 338 of Umatilla County Record of Deeds.

Part 2 being that property designated as Parcel 2 and described in that deed to the State of Oregon, by and through its State Highway Commission, recorded in Book 263, Page 506 of Umatilla County Record of Deeds.

Part 3 being that portion of that property designated as Parcel 2 and described in that deed to the State of Oregon, by and through its State Highway Commission, recorded in Book 277, Page 523 lying Northerly of a line at right angles to the center line of the "B" line crossing of the relocated Oregon - Washington Highway at Engineer's Station "B" 43+00 and Northwesterly of a line parallel with and 30 feet Southeasterly of said center line, which center line is described in said State of Oregon deed.

Part 4 being that property described in those deeds to the State of Oregon, recorded in Book 139, Page 551 and in Book 139, Page 497 of Umatilla County Record of Deeds.

ALSO that portion of that property described in those deeds to the State of Oregon, recorded in Book 139, Page 614 and in Book 139, Page 612 of Umatilla County Record of Deeds lying Southerly of a line at right angles to the center line of the relocated Oregon - Washington Highway at Engineer's Station 1420+00, which center line is described in that deed to the State of Oregon, by and through its State Highway Commission, recorded in Book 257, Page 125 of Umatilla County Record of Deeds.

EXCEPT therefrom that property described in that deed to Key Brothers Inc., recorded in Book 279, Page 621 of Umatilla County Record of Deeds.

This relinquishment is made and executed in furtherance of those certain Highway Commission Resolutions dated September 29, 1960 and November 22, 1963 and those Agreements entered into by the parties herein, dated May 4, 1959 and December 12, 1960. The property herein relinquished is no longer needed or required for State highway, park or scenic purposes.
