All that part of the property of W. H. Frazier in Sections 12, a and 13, T. 5 N., R. 35 E., W. M., included within a strip of land 50 feet wide, being 25 feet on each side of the center line of the Oregon-Washington Highway No. 8, as surveyed over and across said property and as more particularly described as follows:

Beginning at a point which is approximately 1492.0 feet East and approximately 102.0 feet North of the 1/4 section corner between sections 13 and 14, Twp. 5 N. R35 E.W. M. Umatilla County Statee of Oregon: running thence N. 46° 40' E. 537.3 feet; thence on a 8 curve to the left whose central angle is 23° 36', 295.0 feet; thence North, 23° 04' E. 607.3 feet; thence on a 3 curve to the left whose central angle is 7° 56'; 264.4 feet; thence N. 15° 08' E. 917.4 feet; thence on a 3 curve to the left whose central angle is 5° 08' - 171.1 feet; thence N. 10° 00' E. 238.4 feet; thence on a 2 curve wto the left whose central angle is 4° 53' 244.2 feet; thence N. 5° 07' E. 293.8 feet; thence on a 4 curve to the left whose central angle is 4° 25' - 110.4 feet; thence N. 0° 42' curve to the right whose central angle is 23° 30' 552.9 feet to a point in the center of the present traveled county road which point is approximately 1628.0 feet North and approximately 2839.9 feet East of the corner of sections 11, 12, 13, and 14 T. 5 N.
