in the State of Oregon. in consideration of the benefits and other valuable considerations, and the sum of

paid to us, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the

County of Umatilla, State of Oregon, the following described parcel of land, situated

in Umatilla County, in the State of Oregon, to-wit: A strip of land 60 feet wide

being 30 feet on each side of the center line of said road, as surveyed over and across

SW 1/4 of SW 1/4 of Sec. 14, T.5 N.R. 35 E.W.M.

All that part of the property of H. B. Lee in the S.W. 1/4 of the S.W. 1/4 of Section 14, T.5 N.R. 35 E.W.M., included within a strip of land 60 feet in width, being 30 feet on each side of the center line of the Oregon-Washington Highway No.8, as surveyed over and across said property and as more particularly described as follows:

Beginning at a point approximately 910.0 feet North and 708.0 feet East of the corner of Sections 14, 15, 22 and 23, T.5.N.R. 35 E.W.M., Umatilla County, State of Oregon; thence N. 31° 52' W. 213.0 feet; thence on a 10° curve to the right, whose central angle is 10° 10', 67.0 feet to a point approximately 1140.0 feet North and approximately 765.0 feet East of the corner of Sections 14, 15, 22 and 23, T.5.N.R. 35 E.W.M.; said tract of land containing 0.37 acres of land more or less.
