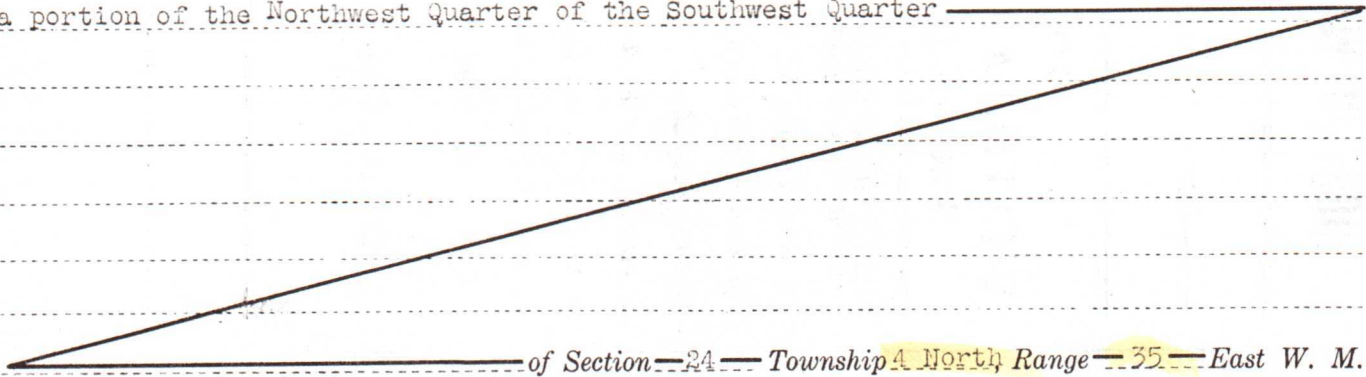
Known as the Weston Mountain Highway

Know all men by these presents, That Elmer Tucker and Marjorie Tucker, his wife,

of the County of Umatilla

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar paid to them, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across a portion of the Northwest Quarter of the Southwest Quarter

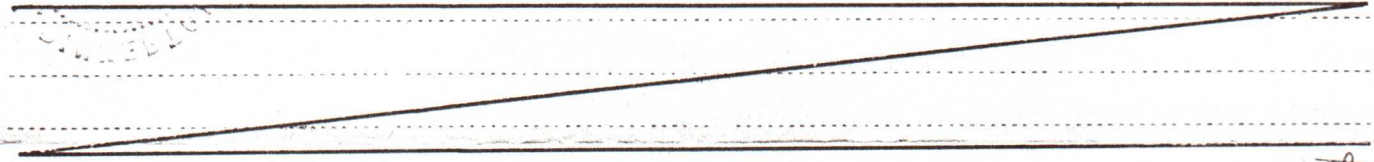


of Section 24 Township 4 North Range 35 East W. M. Beginning at Station 95 & 61 of the Weston Mountain Highway Survey

which Station is approximately 296 feet west and feet of the Corner of the 1/16 Section Corner in the center of the Southwest Quarter of said Section 24, which is common to Sections Township Range East W. M.

Thence running in a general westerly direction approximately 1151 feet to Station 107 & 12 of the said survey, which Station is approximately 269 feet east and feet of the Northwest corner which is common to Sections of the Southwest Quarter Township of the Range East W. M. Southwest Quarter of Section 24, Township 4 North, Range 35 East, W.M. Contains 1.59 acres more or less.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
