and it appearing to the court at this time, that said road so proposed
to be vacated in not useful as a part of the general road system
of Umatilla County, Oregon, there being another road established and
opened taking the place thereof, and it appearing that the public
will be benefitted by such vacation, and such road will not in
the future be useful as a part of the general road system and is not
of sufficient public benefit to warrant the same being maintained by
the county.

IT IS THEREFORE HEREBY ORDERED by the court, that that
road heretofore described, in the resolution in the above entitled
matter should be vacate d and the same is hereby vacated, upon completion
of Weston Mt. Market Road through J.H. Key ranch.

RESOLUTION

BE IT RESOLVED by the County Court of the State of Oregon,
for Umatilla County, sitting for the transaction of County business,
that proceedings to vacate a portion of a county road described as
follows:

Beginning at the 1/16 corner on the south half of the
section line between sections 22 and 23, Township 4 North, Range 35
East W.M. thence east following present traveled road along 1/16
section line to the 1/16 section corner on the south half of the
north and south center line thru Section 23, T. 4 N.E.35 E.W.M.
thence following present traveled road to a point where said road inter-
sects the Weston Mountain Market Road, said point of intersection
being approximately 1235 feet south and 325 feet west of the
section corner common to Sections 23, 24, 25 and 26,
Township 4 North Range 35 East W.M. said road being 40 feet wide 20
feet on each side of the above described center line, shall be under-
taken; that said road is useless as a part of the general road
system; is burdensome and dangerous to maintain and that the people
and public will be benefitted by the vacation of that part of said
road above described.

IT IS ORDERED that the Clerk of this Court, in its behalf
shall notify the County Roadmaster of Umatilla County, Oregon of the
proceeding instituted by the foregoing Resolution and said County
Roadmaster is directed to examine the road mentioned in said resolution
and make a report in writing on the same and on the matter mentioned
in the Resolution.
