

1 To the Honorable, the County Court of
2 the State of Oregon for the County of
3 Umatilla.

4 The undersigned your Petitioners
5 house holders of the County of Umatilla
6 and State of Oregon and residents
7 within the vicinity of the proposed
8 County road herein after mentioned
9 and described, most respectfully
10 petition the Honorable Court to locate
11 layout and establish a County
12 Road ^{110 feet wide} as follows to wit:

13 Commencing on the State line be-
14 tween the State of Oregon and the Terri-
15 tory of Washington, at a point 5 chains
16 and 50 links west of where the Section
17 line running north and south
18 between sections 14 and 15 in Town-
19 ship 6 north of Range 35 last W. 111.
20 crosses the said State line. Running
21 thence in a southeasterly direction
22 across the land of R. Wells to the line
23 running between said sections 14 and
24 15 at a point 80 Rods north of the
25 south west corner of said Section 14.

26 Thence south on said section line on
27 the lands of Lewis Whites and John
28 Lewis, 80 Rods,

29 Thence south on the Sec-
30 tion line between sections 22 and 23
31 in said Township about three-
32 fourths of a Mile, over the lands of

1 O.R. Ballan and lands belonging to
2 the estate of Alexander Ferguson deceased
3 and M. J. Smith James Bayes and
4 Joseph Perry.

5 Thence southerly on the
6 most practicable route over the
7 lands of Joseph Perry, A. Morand
8 Dr. Lowe, Nancy Weller, N. Ford
9 Mr. Crogoe, S. B. Briggs & Charles
10 Anderson, Frank Sullivan,
and C. Rodgers to the south west
11 corner of Section 26 in said
12 Township.

13 Thence south on the
14 section line between sections
15 34 and 35 in the Township
16 aforesaid one mile, on the lands
17 formerly occupied by one J.
18 Bartlett ^{and of the lands of} Wm. Forsyth, George
19 Lydell Cornelia O. McCarter
20 and W.S. Powell.

21 Thence south on the line
22 between sections 2 and 3 in town
23 ship 5 North of Range 35 East M. 7 N.
24 about 90 rods to a point ^{near} where the A.R. & N.
25 Rail Road crosses said section line,
26 over the lands of W.S. Powell W. J. Wright
27 and W. P. Crow; Thence in a westerly
28 by direction about one half of a mile
29 along the north side of the line of said rail road
30 to where the said rail road crosses the
31 west line of the corporate limits of

Milton ^{and} in said county of Minn. over the lands of W. P. Loran and W. J. Wright, and your Petitioners hereby ask the Hon. Court to vacate a county road known as the Mudgett and Milton road from where the above proposed road intersects the said Mudgett ^{and Milton} Road, as follows, commencing at the north West corner of the S.W. 1/4 of Section 35 in Township 6 north of Range 35 - east 7th W.M. running there in a south easterly direction across said S.W. 1/4 of said Section to where said Mudgett ^{and Milton} road intersects what is known as the lower road running from Milton in Minn. county, Oregon to the State line. and your Petitioners ask the Hon. Court to appoint a viewer and a surveyor to survey and mark said proposed road, and your Petitioners as in duty bound will ever pray. Dated this Aug 2nd 1887
