A strip of ground for Highway purposes being 60 feet wide, 30 feet on each side of the center line as now surveyed and located, over and across Lot 2, Section 8, Township 3 N. Range 36 E.W.M., the point of beginning being 440 feet more or less South of the northwest corner of the Southeast Quarter of Section 8, said Township and Range; said point being on a unit spiral curve to the right, the bearing of a line tangent to the spiral at the point of beginning being N. 62 48.5' E.; thence continuing around the spiral, the long cord of which bears N. 65 37' E. a distance of 201.8 feet; thence continuing around the spiral to the right, the long cord of which bears N. 72 40.5' E. a distance of 300 feet; thence N. 74 47.5' E. a distance of 442.7 feet; thence around a unit spiral curve to the left, the long cord of which bears N. 73 22.5' E. a distance of 200 feet; thence continuing around the spiral to the left, the long cord of which bears N. 64 52.5' E. a distance of 200 feet; thence N. 66 17.5' E. a distance of 152.5 feet, more or less, to the East and West center line through section 8, Township 3 North, Range 36 E.W.M., all located in Section 8, Township 3 North, Range 36 E.W.M.
