All that part of the property of V.B.Harris in Sec.19, T. 4 N.R.35 E.W.M., included within a strip of land 40 feet wide, being 20 feet on each side of the center-line of the Oregon-Washington Highway No.6, as surveyed over and across said property and as more particularly described as follows:

Beginning at a point in the center of the existing County road approximately 2525.0 foot East of the corner of Sections 24, 25, 19 and 30, T. 4 N.R. 34 and 35 E.W.M., Umatilla County, State of Oregon; thence on a 28° curve to the left, whose central angle is 69°43'; 320.4 foot to a point in the center of the existing County road approximately 2723 feet East and approximately 204.0 feet North of the corner of Sections 24, 25, 19 and 30, T. 4 N.R. 34 and 35 East W.M., said tract of land containing 0.13 acres of land more or less.
