have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on

each side of the center line of said road, as surveyed over and across the Southeast Quarter of Section 32 and the Southwest Quarter of Section 33 Township 4 North, Range 35 East, Willamette Meridian. Said center line being more particularly described as follows: Beginning at a point known and designated as Station 137 / 52, which point is 1320 feet North, and 670 feet West of the Southeast Corner of Section 32, Township 4 North, Range 35 East Willamette Meridian. Thence, South 35 degrees 54 minutes East 1545.8 feet to a point known and designated as Station 152 / 97.8; which point is 20 feet North and 160 feet East of the above described Section Corner.

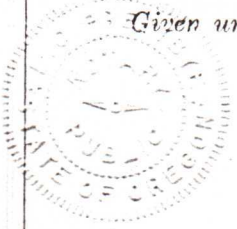
