WHEREAS, the Umatilla County Board of Commissioners may, under authority of ORS 368.201 to 368.221, order a county road that has been used and traveled by the public for ten (10) years or more to be surveyed and recorded, and

WHEREAS, the Umatilla County Board of Commissioners ordered the survey of a portion of Harris Road (County Road #697) lying south of Umapine in Sections 25 and 36, Township 6 North, Range 34 E.W.M., and

WHEREAS, the Notice of Hearing was posted and all owners of abutting property affected by the legalization procedure were served copies of the Notice of Hearing, and

WHEREAS, the Umatilla County Board of Commissioners on January 3, 2001, held a public hearing and finding that it would be in the public interest to legalize the road:

THEREFORE IT IS NOW ORDERED that the road be legalized as follows:

A 40-foot wide right-of-way lying 20 feet on each side of the following described centerline:

Commencing at a brass-capped monument marking the Northwest Corner of Section 36, Township 6 North, Range 34 E.W.M.; thence S87°17'17"E, 1264.40 feet to a 5/8" rebar set on the North-South Centerline of the Northwest ¼ of said Section 36 and the true point of beginning of this description; thence 95.90 feet along a 63.02-foot radius curve right (the chord bears N45°26'46"E, 86.91 feet) to a 5/8" rebar; thence N89°02'27"E, 937.88 feet to a 5/8" rebar; thence N89°11'18"E, 166.26 feet; thence 274.75 feet along a 180.45-foot radius curve left (the chord bears N45°34'07"E, 248.97 feet); thence N01°56'56"E, 242.58 feet to a railroad spike and the terminus of this description.

THE PLAT OF THE ABOVE DESCRIBED ROAD IS RECORDED AS UMATILLA COUNTY SURVEY NO. 00-250-C.
