

To the Honorable County Court of the State of Oregon, for Umatilla
County :

We, the undersigned your petitioners, who are residents and householders in Umatilla County, Oregon, and who reside in the vicinity of the hereinafter described route for a County road, respectfully petition your honorable body to cause to be laid out, located and established, a County road in said County and State commencing, running and terminating as follows, to-wit :

Commencing at a point on west side of railroad right of way known as the Hunt line, and as near as practicable to the center of section 35 T5 NR34 E1/4M, and running in a southeasterly direction parallel to said right of way, to a point on section line between sections 12 and 13 T4 NR34 E1/4M, thence across said right of way to east side thereof, then continuing in a southeasterly direction and parallel to said right of way, to a point on the quarter line of sections 13 T4 NR34 E1/4M, thence east on said quarter line to the township line between townships 4 and 4 of ranges 34 and 35 E1/4M then running south on said township line one half (1/2) mile to the section corner

Said road to be *Forty* feet wide.

And your petitioners will ever pray.
