WHEREAS, a road notice has been posted of which the following is substantially a copy, to-wit:-

ROAD NOTICE.

TO ALL PERSONS WHOM IT MAY CONCERN:

Notice is hereby given that a petition will be presented to the County Court of the State of Oregon for Umatilla County, by the undersigned, who are residents and householders of said County and State and reside in the vicinity of the hereinafter described route for a County road, at the September term of said County Court, to-wit: on the 3rd day of September 1894, praying said Court to lay out, locate and establish a County road in said County and State, commencing, running and terminating as follows, to-wit:-

Beginning at a point on the West side of the rail road right of way, known as the Hunt line and as near as practicable to the center of section 35 T. 5 N. R. 34 E. W. M. and running in a southeasterly direction parallel to said right of way to a point on section line between sections 12 and 13 T. 4 N. R. 34 E. W. M.; Thence across said right of way to the east side thereof; Thence continuing in a southeasterly direction and parallel to said right of way to a point on the quarter line of section 13 T. 4 N. R. 34 E. W. M.; then east on said quarter line to the Township line between Townships 4 and 4 of ranges 34 and 35 E. W. M.; Thence south on said township line one (1/2) half mile to the section corner, said road to be forty feet wide.

And WHEREAS, in the opinion of the undersigned subscribers, the above described County road is unnecessary, there being a County road for all of said distance, running on section and half section lines and at no place more than one half mile distant from the proposed route, and

WHEREAS, in our opinion the route proposed is in many places unsuitable for a road, and

WHEREAS, said road would greatly damage much of the property through it is proposed to be run, it angling across six separate farms, and

WHEREAS, there are good reasons to believe that the facts in regard to said location were misrepresented to many of the subscribers to said petition,

NOW THEREFORE, we the undersigned, being residents and householders within the State of Oregon and County of Umatilla and residing in the vicinity of said proposed road or having property through which said proposed road would run, do respectfully remonstrate to your Honorable Body against the laying out, locating and establishing of any such proposed County road.
