

Now on this day comes the Petition of J. S. Hodgen & 22 others praying the Court to appoint Viewers & Surveyor, to view out survey & locate the above mentioned road as a County Road in & for Umatilla County, Oregon as follows, to-wit:-

Commencing on the section line about one fourth of a mile South of the North West Corner of Section 22 Township 6 North of Range 35 East of the W.M. thence Easterly direction about 40 Rods more or less to the old Rail Road bed thence a westerly direction on the old Rail Road bed to the section line between Section 15 & 22 in said Tp. thence East on said section line to the North East Corner of Section 22 thence South on the section line between Section 22 & 23 about one fourth of a mile thence a Easterly direction about one half of a mile to intersect a County Road running from the State line to the City of Milton in Umatilla County Oregon said road to be 40 feet wide.

And it appearing to the Court from the proofs & papers filed herein that due notice of the pendency of this proceeding has been given by the posting of notices as by law required, & that more than twelve of said petitioners are resident householders residing in the vicinity of the above mentioned road, & that a good & sufficient bond has been given for the payment of the view & survey of the said proposed road, (in the event said road be not granted) duly approved by the Court.

It is therefore ordered by the Court that E. D. Stillman, Peter Gerking & John Hughes be & they are hereby appointed viewers & J. C. Arnold, Surveyor to view out, survey & locate the above mentioned & proposed road as a County road in & for Umatilla County, Oregon, & that they report their doings thereon to this Court at the May 1889 Term thereof, to commence on the First Monday in May 1889 & that they meet at John Hughes house on the 21<sup>st</sup> day of April 1889 & duly qualify before entering upon the discharge of their duties in this behalf.
