5- N. of R. 34 East; Thence East on said line to  
the center of section 34, T<sup>p</sup> 5, N. of R. 34, E.; Thence  
south on the line between the S. E.  $\frac{1}{4}$  and S. W.  $\frac{1}{4}$   
of said section 34 to the Township line  
between Townships 4 and 5 in said Range  
; Thence East on said Township line to the  
County road springing <sup>across</sup> Alkali Flat. to  
~~geysers and~~ <sup>Centerville</sup> County road  
All in Umatilla County State of Oregon  
Provided that these lines, courses, <sup>and distances</sup>  
be subjected to the provision of the Oregon  
Code to the effect that the viewers locate  
the road on the line petitioned for, or as  
near as in their opinion a good road  
can be made at a reasonable expense  
taking into consideration the utility  
convenience and inconvenience and  
expense which will result to individuals  
as well as to the Public if such a road  
be established;
