have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in

Umatilla County, State of Oregon, to-wit: A strip of land sixty (60) feet wide, being thirty (30) feet wide on each side of the center line of the Gerking Flat Road as the same is

surveyed over and across the North half of the Northwest Quarter of Section 10, Township 4 North, Range 34 East, W.M. The above mentioned center line being more particularly

described as follows: Beginning at a point on the 1/16 section line 395 feet East of the Southwest corner of the said North half of the Northwest Quarter of Section 10, thence

North 30° 45' West, 842 feet to a point on the section line 665 feet South of the section corner common to Sections 3, 4, 9 and 10. All in Township 4 North, Range 34 East,

W.M. Contains 1.15 acres more or less.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
