the State of Oregon, to-wit: A strip of land Sixty(60) feet wide, being Thirty(30) feet on
each side of the center line of said road, as surveyed over and across the
N.W. quarter of Section 12, T.3N, R.34 E.W.M., said center line being described as
follows; Beginning at a point approximately 1890 feet South of the corner common
to Sections 1, 2, 11, and 12 T.3N, R.34 E.W.M., thence in a general south easterly
direction a distance of approximately 1255 feet to a point approximately 2640
feet North and 790 feet East of the corner common to Sections 11, 12, 13, and 14,
T.3N, R.34 E.W.M., containing 1.73 acres more or less.
