have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Thirty (30) feet wide, being Thirty (30) feet on

the South side of the center line of said road, as surveyed over and across the South half of Sec. 3 T. 34 N. R. 34 E. W. M.; said center line being described as follows; Beginning at a point where the East Right of Way line of the O. W. R. R. & N. Co. crosses the East and West line through the center of Sec. 3, T. 34 N. R. 34 E. W. M., thence N. 89° 30' E. a distance of approximately 3692 feet, containing 2.54 Acres more or less.
