paid to them, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on

each side of the center line of said road, as surveyed over and across the S.E. Quarter of Sec. 3, T. 3N., R. 34E. W.M., said center line being described as follows; Beginning at a point approximately 442 feet West of the Quarter Corner between Sections 2 and 3 T3.NR34E. W.M., thence South 72 32' East a distance of approximately 491 feet to a point 2500 feet North of the Corner common to Sections 2, 3, 10 and 11, T. 3, N. R. 34E. W.M. containing 0.68 acres more or less.
