have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across the North-

half of the Northwest Quarter of Section 22. Said center line being more particularly described as follows; Beginning at a point on the Section line 1245 feet east of the Section corner common to Sections 15, 16, 21 and 22, thence South 45° 16' East, 340.0 feet, thence on a 716.8 feet radius curve to the right, 250.6 feet, thence South 25° 13' East, 990.0 feet to a point on the south line of the North half of the Northwest Quarter of Section 22, which point is 1320 feet south and 2007 feet east of the Section corner common to Sections 15, 16, 21 and 22. All in Township 3 North, Range 34 East, W.M.
