each side of the center line of said road, as surveyed over and across the Southeast Quarter of Section 22, T. 3 N. R. 34 E. W.M. Said center line being more particularly described as follows; Beginning at a point known and designated as Station 172 1/2 of the said highway survey which point is 1320 feet north and 2210 feet west of the Section corner common to Sections 22, 23, 26 and 27, T. 3 N. R. 34 E. W.M., thence South 13 23' East, 1380 feet, to a point known and designated as Station 185 1/2 of the said highway survey, which point is located on the Section line and 1915 feet West of the Section Corner common to Sections 22, 23, 26 and 27, Township 3 North, Range 34 East.
