forth in the executed agreement. further,


It is my opinion that the said roads will be usefull to the community <sup>and</sup> will  
~~improve~~ <sup>improve</sup> the networks of the general road system of Umatilla County. The said  
Indian Service Roads have been open for public travel, all with minimum required  
right-of-way width of 50 feet and it would be advisable to preserve the same  
for the Umatilla County Road Department road system in the future, and that the  
public will be benefited by it's adoption. therefore,

I conclude, and RECOMMEND that the said Indian Service Roads hereinafter listed  
and more particularly described in seperate sheet attached hereto and by this  
reference made a part hereof, as aforesaid the County Court to pursue enactment  
to legalize the said roads into County Road system.
