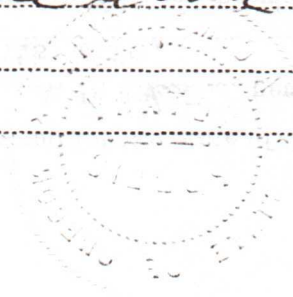
Umatilla County, State of Oregon, to-wit: A strip of land 60 feet wide being 30 feet wide on each side of the center line of the survey and described as follows: beginning at a point 510 feet north and 20 feet east more or less of the section corner common to sections 1, 2, 11 and 12, Twp 4, North, Range 33, E.W.M.; thence along a tangent with an approximate bearing of North 57° 24' East for a distance of 718 feet; thence around a 5° C. L. for a distance of 773.3 feet; thence along a tangent with an approximate bearing of North 18° 44' East for a distance of 1167.9 feet to a point which point is 1418 feet west and 1715 feet south of the North East corner of the North West 1/4 of Section 1, Twp 4 North, Range 33, E.W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
